I am pleased to inform your Honorable Body that I have signed into law this day these bills which are routine and require no special treatment:

**Bill 21-0005** - An Ordinance concerning - Zoning - Conditional Use Conversion of a Single-Family Dwelling Unit to 2 Dwelling Units in the R-7 Zoning District - Variances - 810 Argonne Drive - For the purpose of permitting, subject to certain conditions, the conversion of a single-family dwelling unit to 2 dwelling units in the R-7 Zoning District on the property known as 810 Argonne Drive (Block 3913C, Lot 021), as outlined in red on the accompanying plat; providing for a special effective date; and granting variances from certain bulk regulations (lot area size), gross floor area per unit type, and off-street parking requirements.

**Bill 21-0006** - An Ordinance concerning - Rezoning - 407 Benninghaus Road - For the purpose of changing the zoning for the property known as 407 Benninghaus Road (Block 5014C, Lot 004A), as outlined in red on the accompanying plat, from the R-3 Zoning District to the OR-1 Zoning District.

**Bill 21-0010** - An Ordinance concerning - Rezoning - 2087 Druid Park Drive - For the purpose of changing the zoning for the property known as 2087 Druid Park Drive (Block 3390B, Lot 036), as outlined in red on the accompanying plat, from the I-1 Zoning District to the IMU-1 Zoning District.

**Bill 21-0011** - An Ordinance concerning - Rezoning - 2426 Pennsylvania Avenue - For the purpose of changing the zoning for the property known as 2426 Pennsylvania Avenue (Block 0294, Lot 014), as outlined in red on the accompanying plat, from the OR-1/R-MU Zoning District to the C-1-E Zoning District.

**Bill 21-0013** - An Ordinance concerning - Rezoning - 4015 Foster Avenue, 4000 Hudson Street, and 801 South Haven Street - For the purpose of changing the zoning for the properties known as 4015 Foster Avenue (Block 6447 Lot 021) and 4000 Hudson Street (Block 6457, Lot 018), as outlined in red on the accompanying plat, from the I-1 Zoning District to the IMU-2 Zoning District; and changing the zoning for the property known as 801 South Haven Street (Block 6458, Lot 003), from the I-2 Zoning District to the IMU-2 Zoning District, as outlined in blue on the accompanying plat.

**Bill 21-0015** - An Ordinance concerning - Conditional Use Parking Lots - 115 and 118 Mount Clare Street - For the purpose of permitting, subject to certain conditions, the establishment, maintenance, and operation of parking lots on the properties known as 115 Mount Clare Street (Block 0251, Lot 068) and 118 Mount Clare Street (Block 0251, Lot 072), as outlined in red on the accompanying plat; and providing for a special effective date.

**Bill 21-0021** - An Ordinance concerning - Late Fees for Past Due Rent - For the purpose of requiring a lease to have a provision regarding a 10-day grace period; requiring a lease to have provisions regarding the amount of money landlords may charge for late fees, when landlords may charge tenants receiving public assistance for late fees, late fees as a condition precedent to

the tenant's right to redeem, and the types of fees landlords may recover; and prohibiting this section from altering other remedies available to a landlord.

**Bill 21-0024** - An Ordinance concerning - Minority and Women's Business Utilization – Emergencies - For the purpose of clarifying the City's minority business and women's business contract utilization requirements for certain emergency procurements; requiring that, after an emergency procurement, the agency submit a report to the Board of Estimates and the Minority and Women's Business Opportunity Office; providing for a special effective date; and generally relating to greater transparency and utilization of minority and women's business in City emergency contracting.

#### INTRODUCTION AND READ FIRST TIME

The President laid before the City Council the following bills and Resolutions of the Mayor and City Council for first reading:

**Bill No. 21-0060** - By Councilmembers Burnett, Cohen, Dorsey, Bullock, Middleton, Ramos

An Ordinance requiring that the Baltimore City Fire Department submit a report to the Mayor and City Council evaluating certain promotional practices of the Department; specifying the contents of the report; and providing for a special effective date.

The bill was read the first time and referred to the City Solicitor, Department of Finance, Baltimore City Fire Department, City Administrator, Department of Human Resources, Labor Commissioner, Office of Equity and Civil Rights, and the Public Safety and Government Operations Committee.

**Bill No. 21-0061** - Councilmembers Burnett, Cohen, Dorsey, Bullock, Porter, Middleton, Ramos, Torrence

An Ordinance modifying the applicable self-performance credit for minority and women's business enterprise prime contractors.

The bill was read the first time and referred to the City Solicitor, Department of Finance, Minority and Women's Business Opportunity Office, Mayor's Office of Minority and Women's Business Development, and the Public Safety and Government Operations Committee.

**Bill No. 21-0062** - Councilmembers Costello, Schleifer, Cohen, Bullock, Porter, Middleton, Torrence, Conway, Glover, Stokes

An Ordinance revising the definition of “newly constructed”; clarifying and extending the tax credit qualification deadlines for certain high-performance newly constructed dwellings; clarifying the termination of the tax credit program; conforming and clarifying related provisions; defining a certain term; and providing for a special effective date.

The bill was read the first time and referred to the City Solicitor, Department of Finance, Department of Planning, Baltimore Development Corporation, Live Baltimore, and the Ways and Means Committee.

The President laid before the City Council the following Council Resolutions for first reading:

**Bill No. 21-0036R** - By Councilmembers Ramos, Bullock, Porter, Middleton, Glover, Conway, Torrence, Burnett, Cohen, Dorsey, Stokes

A Resolution calling for a multi-faceted and comprehensive hearing on the looming eviction crisis and what we can do to avoid it by: inviting the Executive Director of the Mayor’s Office of Children and Family Success, the Acting Commissioner of the Baltimore City Department of Housing and Community Development, and the Executive Director of the Community Action Partnership, to report on the outcomes of the Eviction Prevention Program and what more can be done; inviting representatives from the Mayor’s Office of Immigrant Affairs and the Esperanza Center to discuss the challenges renters who are immigrants are facing and provide recommendations on additional protections; and inviting representatives from the Public Justice Center and the Fair Housing Action Center of Maryland to report on evictions thus far, outline the rights of tenants now and the rights granted by new laws passed in the General Assembly and the City Council, and make recommendations for additional protections.

The resolution was read the first time and referred to the City Solicitor, Department of Finance, Mayor’s Office of Children and Family Success, Department of Housing and Community Development, Mayor’s Office of Immigrant Affairs, Housing Authority of Baltimore City, and the Economic and Community Development Committee.

**Bill No. 21-0037R** - By Councilmember Porter, Bullock, Middleton, Ramos, Cohen, Conway, Stokes, Glover, Burnett, Torrence

A Resolution inviting representatives from the Baltimore City Law Department, the Department of Housing and Community Development, and the Department of Health to discuss the feasibility of certain specific recommendations to more efficiently and rapidly improve the ability of Baltimore City to remedy vacant dwellings.

The resolution was read the first time and referred to the City Solicitor, Department of Finance, Department of Housing and Community Development, Department of Health, and the Economic and Community Development Committee.

**Bill No. 21-0038R** - By Councilmember Stokes, President Mosby, Councilmembers Cohen, Middleton, Porter, Ramos, Glover, Burnett, Torrence

### A COUNCIL RESOLUTION CONCERNING

#### **Banning Contracts with Georgia Due to Voter Suppression**

FOR the purpose of urging the Mayor and Board of Estimates to refuse to permit municipal officials to travel to the State of Georgia on City business and to refuse to contract with the State of Georgia or businesses based in Georgia until Georgia's newly-enacted voter suppression law is repealed.

#### **Recitals**

**WHEREAS**, The right to vote is fundamental to the function of healthy democracy;

**WHEREAS**, Members of minority groups, in particular African Americans, have historically been the target of legislation meant to deprive them of the free and fair exercise their right to vote;

**WHEREAS**, In 2020, unprecedented numbers of Georgians, especially African Americans, turned out to vote in general and special elections;

**WHEREAS**, Georgians elected Joe Biden to the Presidency of the United States and Reverend Raphael Warnock and Jon Ossof to the United States Senate – President Biden, Senator Warnock, and Senator Ossof are all members of the Democratic Party;

**WHEREAS**, Following these elections, prominent members of the Republican Party from Georgia and elsewhere, including former President Donald Trump, persistently made baseless, wholly unsubstantiated claims that the election results were illegitimate and the result of pervasive fraud;

**WHEREAS**, Georgia's Republican-led legislature passed and, on March 25, 2021, the Governor of Georgia signed into law a series of voting restrictions that are expected to significantly impair Georgians' right to vote;

**WHEREAS**, The new Georgia law suppresses voting in a variety of ways including undue burdens on the ability of voters to vote absentee or cast ballots by mail, restricts access to ballot drop boxes, restricts the ability of local and state election administrators to provide voters access to ballots, changes the administration of the Georgia’s primary elections, and prohibits volunteers from offering food or beverages to voters forced to wait in long lines to cast a ballot;

**WHEREAS**, These restrictions are intended and expected to disproportionately disenfranchise African Americans;

**WHEREAS**, President Biden has labeled this new voter suppression law “Jim Crow in the 21<sup>st</sup> Century”;

**WHEREAS**, Previous Mayors of Baltimore have used their authority to set fiscal and administrative policies for the City that advance the causes of justice and equity, including prohibiting travel by municipal officials to certain states while unjust policies remained in place; and

**WHEREAS**, the Board of Estimates is responsible for overseeing fiscal policy, making procurement decisions, and approving contracts on behalf of the residents of Baltimore.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE**, That the City Council urges the Mayor and Board of Estimates to refuse to permit municipal officials to travel to the State of Georgia on City business and to refuse to contract with the State of Georgia or businesses based in Georgia until Georgia’s newly-enacted voter suppression law is repealed.

**AND BE IT FURTHER RESOLVED**, That a copy of this Resolution be sent to the Mayor, the Comptroller, the City Solicitor, the Director of the Department of Public Works, the City Administrator, the Clerk of the Board of Estimates, and the Mayor’s Legislative Liaison to the City Council.

Councilmember Stokes made a motion, which was duly seconded, that the Rules be suspended.

#### **COMMITTEE REPORTS**

##### **BILL NO. 21-0016R REPORTED FAVORABLY AND ADOPTED**

Councilmember McCray, for the Health, Environment, and Technology Committee, reported Bill No. 21-0016R favorably.

#### **A COUNCIL RESOLUTION CONCERNING**

##### **Investigative Hearing – Building Backups of Untreated Sewage**

FOR the purpose of inviting representatives from the Department of Public Works, the Law Department, the Health Department, and the Mayor’s Office of Emergency Management to appear before the City Council to discuss the effectiveness and sufficiency of measures being taken to address basement backups of raw sewage in the City.

#### **Recitals**

Exposure to raw sewage poses a serious risk to human health. Raw sewage contains a variety of microorganisms, viruses, bacteria, and parasites that can cause serious illnesses including cholera, hepatitis, cryptosporidiosis, and giardiasis. In addition, moisture in homes, including

moisture from sewage backups, can cause the growth of toxic fungi and mold. Among other health risks, mold can trigger asthma attacks.

Cleaning up and disinfecting interior spaces after a sewage backup, or securing a licensed contractor to perform that work, is a costly and traumatic endeavor that poses economic hardships to many Baltimore City residents.

In 2002, Baltimore City entered into a Consent Decree with the Environmental Protection Agency (“EPA”) and the Maryland Department of the Environment (“MDE”) to address violations of the federal Clean Water Act from discharges of untreated sewage from Baltimore’s collection system into the Back River, Patapsco River, the Chesapeake Bay, and other waters of the United States.

Under the 2002 Consent Decree, Baltimore’s Department of Public Works (“DPW”) was required to conduct a thorough investigation of its wastewater collection system and undertake certain systematic and operational improvements to eliminate sanitary sewer overflows (“SSOs”) and otherwise achieve compliance with the Clean Water Act and analogous State law. The corrective measures required under the 2002 Consent Decree were to be completed by 2016, but the City failed to meet the deadline.

In 2017, the City entered into a Modified Consent Decree with the EPA and MDE that set forth new requirements and deadlines for the City to achieve compliance into two phases. The deadline for completion of Phase I was January 2, 2021, and Phase II is to be completed by December 31, 2030.

Pursuant to the Modified Consent Decree, DPW is required to establish a “Building Backup Expedited Reimbursement Program” (the “Program”) to reimburse City homeowners, renters, non-commercial occupants, and residents for the costs of cleaning up and disinfecting after certain building sewage backups that are the result of surcharging in the collection system caused by wet weather events. The Program has been in a three-year pilot stage between April 2018 and April 2021. This year, the City, MDE, and EPA must agree on a permanent version of the program that will remain in effect for the rest of the term of the Modified Consent Decree.

Under the Modified Consent Decree, the City is required to track certain information related to the Program and report it to the EPA, MDE, and the public on an annual basis. These reports are found in Modified Consent Decree Quarterly Report #7 for the first year of the Program (April 2018-April 2019), and Modified Consent Decree Quarterly Report #11 for the second year of the Program (April 2019-April 2020).



According to the City's own data, only 95 applications were made to the Program during its first 2 years, despite the fact that there were over 11,000 reported sewage backups to the City's 311 non-emergency service system. 81 of these applications were denied (85%) and only \$14,775 has been paid out to residents over 2 years despite the fact that \$2 million is set aside annually for these expenses.

Advocates have submitted a comprehensive list of recommendations to Baltimore City, EPA, and MDE for improving the Program. During an investigative hearing before the City Council on July 28, 2020 a DPW representative committed to implementing several of those recommendations, including removing the 24-hour reporting restriction; raising the reimbursement cap to \$5,000; acquiring contracts with entities who can perform direct assistance for residents who experience sewage backups in wet-weather conditions; considering broadening the scope of that direct assistance to include dry-weather sewage backups.

The residents of Baltimore City have a significant and ongoing interest in knowing exactly what terms will be agreed upon in the finalized version of the Expedited Reimbursement Program required under the Modified Consent Decree, but this process is not open to public comment or scrutiny.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE,** That the Council invites representatives from the Department of Public Works, the Law Department, the Health Department, and the Mayor's Office of Emergency Management to appear before the City Council to discuss the effectiveness and sufficiency of measures being taken to address basement backups of raw sewage in the City.

**AND BE IT FURTHER RESOLVED,** That the Council intends that this investigative hearing serve as an opportunity for public comment on the City's progress in handling capacity-related building sewage backups.

**AND BE IT FURTHER RESOLVED,** That a copy of this Resolution be sent to the Mayor, the Director of the Department of Public Works, the City Solicitor, the Director of 311 Services, the Commissioner of the Baltimore City Department of Health, the Director of the Mayor's Office of Emergency Management, and the Mayor's Legislative Liaison to the City Council.

Favorable report adopted.

The roll was called on adoption of the Resolution, resulting as follows:

An Ordinance requiring city-owned or -occupied buildings to place a notice regarding the human-trafficking prevention hotline in certain locations; deleting an obsolete reference to the “Maryland Department of Labor, Licensing, and Regulation”; providing that certain businesses may obtain the required human-trafficking notices from the United States Department of Homeland Security’s Blue Campaign website; and conforming and clarifying related provisions.

Committee Amendments to City Council Bill No. 21-0038

On page 4, strike lines 17 through 25 and substitute:

“(B) EXCEPTIONS.

THIS SECTION DOES NOT APPLY TO:

(1) ANY CITY-OWNED BUILDING THAT IS VACANT OR NOT IN REGULAR USE; OR

(2) ANY CITY-OWNED BUILDING THAT IS OCCUPIED BY THE BALTIMORE CITY  
PUBLIC SCHOOL SYSTEM.”.

On page 1, in line 5, after the semi-colon, insert "clarifying who the Chief of the Fire Department may designate to attend meetings of the Fire and Police Employees' Retirement Board of Trustees on the Chief's behalf;" and, on page 2, in line 27, after "must", insert an opening bracket; and, on that same page, in line 29, after the second comma, insert a closing bracket; and, on that same page, at the beginning of line 30, insert "HOLD A POSITION WHOSE RANK AND RESPONSIBILITIES INCLUDE DECISION-MAKING AUTHORITY ON BEHALF OF THE CHIEF".
