6 7	WHEREAS on Wadnagday March 27th 2024 the Deltimore City Fire Department was the
8	WHEREAS, on Wednesday, March 27th, 2024, the Baltimore City Fire Department was the first on the scene to what was not only a City, but also a State and federal emergency, at the
9	Francis Scott Key Bridge collapse, arriving in less than 10 minutes to begin active triage and
