**AN ORDINANCE CONCERNING**

**City Streets – Closing – A Portion of Falls Road at the  
Intersection of West Cold Spring Lane**

FOR the purpose of condemning and closing a portion of Falls Road located on the east side of Falls Road Northerly 135.5 Feet from the north side of West Cold Spring Lane, as shown on a plat numbered 284-A-17A and dated March 1, 2025, prepared by the Survey Section, and filed in the Office of the Department of Transportation; and providing for a special effective date.

**SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That the Department of Transportation shall proceed to condemn and close a portion of Falls Road located on the east side of Falls Road Northerly 135.5 Feet from the north side of West Cold Spring Lane and more particularly described as follows:

**Description of a

**Ward 27, Section 16, Block 4778-G**

Beginning for Parcel 1 at the point formed by the intersection of the south side of the property known as 4535/4539 Falls Road, variable width and the east side of said Falls Road said point of beginning being distant Northerly 320.5 feet measured along the east

1 side of said Falls Road from the north side of West Cold Spring Lane variable width and  
2 the east side of said Falls Road; thence binding on the south side of said property known  
3 as 4535/4539 Falls Road Easterly 15 feet more or less, to the easternmost of Falls Road:  
4 thence on the easternmost side of said Falls Road Southerly 185 feet more or less, to the  
5 northern side of the property known as 4501 Falls Road; thence binding on said norther  
6 side of said property Westerly 15 feet more or less, and thence Northerly 185 feet more or  
7 less, to the place of beginning.

8 Containing 2775 square feet or 0.0637 acres more or less.

9 As delineated on a plat numbered 284-A-17A, prepared by the Survey Control Section,  
10 and filed on March 1, 2025 in the Office of the Department of Transportation.

11 **SECTION 2. AND BE IT FURTHER ORDAINED,** That the proceedings for the condemnation and  
12 closing of a portion of Falls Road located on the east side of Falls Road Northerly 135.5 Feet  
13 from the north side of West Cold Spring Lane and the rights of all interested parties shall be  
14 regulated by and in accordance with all applicable provisions of state and local law and with all  
15 applicable rules and regulations adopted by the Director of Department of Transportation and  
16 filed with the Department of Legislative Reference.

17 **SECTION 3. AND BE IT FURTHER ORDAINED,** That after the closing under this Ordinance, all  
18 subsurface structures and appurtenances now owned by the Mayor and City Council of Baltimore  
19 continue to be the property of the Mayor and City Council, in fee simple, until their use has been  
20 abandoned by the Mayor and City Council. If any person wants to remove, alter, or interfere with  
21 them, that person must first obtain permission from the Mayor and City Council and, in the  
22 application for this permission, must agree to pay all costs and expenses, of every kind, arising  
23 out of the removal, alteration, or interference.

24 **SECTION 4. AND BE IT FURTHER ORDAINED,** That no building or structure of any kind  
25 (including but not limited to railroad tracks) may be constructed or erected in or on any part of  
26 the street closed under this Ordinance until all subsurface structures and appurtenances owned by  
27 the Mayor and City Council of Baltimore have been abandoned by the Mayor and City Council  
28 or, at the expense of the person seeking to erect the building or structure, have been removed and  
29 relaid in accordance with the specifications and under the direction of the Director of  
30 Transportation of Baltimore City.

31 **SECTION 5. AND BE IT FURTHER ORDAINED,** That after the closing under this Ordinance, all  
32 subsurface structures and appurtenances owned by any person other than the Mayor and City  
33 Council of Baltimore shall be removed by and at the expense of their owners, promptly upon  
34 notice to do so from the Director of Transportation.

35 **SECTION 6. AND BE IT FURTHER ORDAINED,** That at all times after the closing under this  
36 Ordinance, the Mayor and City Council of Baltimore, acting by or through its authorized  
37 representatives, shall have access to the subject property and to all subsurface structures and  
38 appurtenances used by the Mayor and City Council, for the purpose of inspecting, maintaining,  
39 repairing, altering, relocating, or replacing any of them, without need to obtain permission from  
40 or pay compensation to the owner of the property.

41 **SECTION 7. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the date it is  
42 enacted.
