15	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the		
16	Department of Public Works shall proceed to condemn and open a portion of Clarkson Street,		
17	contiguous to the east side thereof, extending from Dickman Street Southerly 320 feet, more or		
18	less, to Moale Street, and more particularly described as follows:		
19	Beginning for Parcel No. 1 at the point formed by the intersection of the east side		
20	of Clarkson Street, 40 feet wide, and the south side of Dickman Street, 66 feet		
21	wide, and running thence binding on the east side of said Clarkson Street,		
22	Southerly 320.0 feet, more or less, to intersect the north side of Moale Street, 66		
23	feet wide; thence binding on the north side of said Moale Street, Westerly 20.0		
24	feet, to intersect a line drawn parallel with and distant 20.0 feet westerly		
25	measured at a right angle to the east side of said Clarkson Street; thence binding		
26	on said line, so drawn, Northerly 320.0 feet, more or less, to intersect the south		
27	side of said Dickman Street, and thence binding on the south side of said		
28	Dickman Street, Easterly 20.0 feet to the place of beginning.
