Major Issues Discussed

1. Chairman Costello called the hearing to order and asked Vice-Chair Clarke to Chair the hearing.
2. Councilman Stokes explained that the bill would facilitate services such as mail and emergency response to the residents along the subject alley. He also discussed his proposed amendment to name the alley “the 200 Block of East Mura Street” in order to address the Law Department’s concerns.
3. Hilary Ruley confirmed that the Law Department could approve the bill if it was amended as described by Councilman Stokes.
4. Representatives for other City agencies confirmed the recommendations in the agencies’ written reports.
5. The Committee voted to recommend Councilman Stokes’ amendment.
6. The Committee voted to recommend the bill favorably with the amendment.
