14	Settlement Proceeds in excess of the revenue relied on by the Board of Estimates in determining					
15	the tax levy required to balance the budget for Fiscal Year 2009.					
16	This additional revenue could not have been reasonably anticipated when the Ordinance of					
17	Estimates for Fiscal Year 2009 was formulated.					
18	This appropriation is made necessary by a material change in circumstances since the					
19	Ordinance of Estimates for Fiscal Year 2009 was formulated or is for a new program that could					
20	not have been reasonably anticipated when that Ordinance of Estimates was formulated.					
21	On May 27, 2009, the Board of Estimates recommended this appropriation to the City
