To whom it may concern:

I am writing to express my strong opposition to the proposed move of the Sisson Street trash drop-off center to Falls Road. Please find my concerns highlighted below.

- Vehicular traffic
  - Closing a portion of Falls Road will significantly increase vehicular traffic on the lower end. The traffic shift would also be a major inconvenience for the residents of Hampden and surrounding neighborhoods accessing Station North and Mount Vernon.
  - Requests for new site proposals in 2023 preferred two points of access, not one
- Adjacency to floodplain
  - Requests for new site proposals in 2023 prohibited sites that were in a floodplain as it increases the risk of pollution. The Potts & Callahan site is very close to a known floodplain, and considering increasingly unpredictable weather patterns, is likely to be at severe risk of flooding.
  - Would this even be in compliance with State of Maryland floodplain management regulations?
  - High risk of environmental pollution resulting from flooding
- Significant noise pollution from trucks, equipment and vehicular traffic will negatively impact native wildlife around Jones Falls
- Undermines the recently publicized Street Car Museum Master Plan
  - Significantly increased traffic on lower Falls Road will discourage museum visitors
- Undermines Midtown Falls Gateway Project
  - Why would city residents and visitors want to use public outdoor spaces directly next to a loud, smelly trash facility with high vehicular traffic?

While I understand that the Sisson Street location may no longer be serving the needs of DPW sanitation workers or the community, I see this as a blatant grab at a valuable piece of property by a powerful private developer, Seawall. The City cannot sacrifice the health of the Jones Falls environmental area or the surrounding infrastructure, both of which are delicate as it is.

I cycle commute through this corridor daily to get to work (and on most weekends for other errands and trips around the city); I can tell you that this stretch of road is horrifically unsafe for me and the countless other cyclists, scooter riders, joggers and dog walkers I see daily. Cars fly by me on the narrow road, often far exceeding the speed limit, and passing me around blind corners with only inches to spare. It is only a matter of time before a pedestrian or cyclist is seriously injured on Falls Rd, a reality that becomes all the more imminent if the city goes through with the proposed relocation.

The promises included:
