6	587-979), to provide funding for infrastructure improvements in support of the East
7	Baltimore Biotechnology project; and providing for a special effective date.

13	Recitals
14	The revenue appropriated by this Ordinance represents funds from General Obligation Bonds
15	in excess of the revenue relied on by the Board of Estimates in determining the tax levy required
16	to balance the budget for Fiscal Year 2006.
17	This additional revenue could not have been reasonably anticipated when the Ordinance of
18	Estimates for Fiscal Year 2006 was formulated.
19	This appropriation is made necessary by a material change in circumstances since the
20	Ordinance of Estimates for Fiscal Year 2006 was formulated or is for a new program that could
21	not have been reasonably anticipated when that Ordinance of Estimates was formulated.
22	On February 1, 2006, the Board of Estimates recommended this appropriation to the City
23	Council.
24	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That
25	\$3,000,000 shall be made available to the Department of Housing and Community Development
