2.	If the application for extension is made between 31-90 days after the permit expires,
	the fee for the extension is 50% of the original permit fee. Alternatively, the applicant
	may apply for a new permit for the work remaining to be completed, with the fee for
	that permit to be based on the scope of that remaining work.

SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it is enacted.
