2	\$5,250,000 shall be made available to the City Council – Service 100 (City Council) as a
3	Supplementary General Fund Operating Appropriation for Fiscal Year 2025, to provide funding
4	for priority projects. The source of revenue for this appropriation is funds from General Fund
5	Assigned Fund Balance in excess of the amount from this source that was relied on by the Board
6	of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2025.
