12	Recitals
13 14 15	The revenue appropriated by this Ordinance represents funds from the Fiscal Year 2008 Fund Balance in excess of the revenue relied on by the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2009.
16 17	This additional revenue could not have been reasonably anticipated when the Ordinance of Estimates for Fiscal Year 2009 was formulated.
18 19 20	This appropriation is made necessary by a material change in circumstances since the Ordinance of Estimates for Fiscal Year 2009 was formulated or is for a new program that could not have been reasonably anticipated when that Ordinance of Estimates was formulated.
21 22	On May 27, 2009, the Board of Estimates recommended this appropriation to the City Council.
23 24 25	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE , That \$2,964,000 shall be made available to the Police Department – Program 201 (Field Operations Bureau) as a Supplementary General Fund Operating Appropriation for Fiscal Year 2009, to
