SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That
Zoning Code § 1-196.1 {"Water dependent facilities"} is renumbered to be Zoning Code
§ 1-196.2 {"Water dependent facilities"}.

SECTION 2. AND BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,
That the Laws of Baltimore City read as follows:

2 (A) *IN GENERAL.*

3 “VIDEO LOTTERY FACILITY” MEANS A FACILITY THAT HAS BEEN AWARDED A VIDEO
4 LOTTERY OPERATION LICENSE BY THE MARYLAND VIDEO LOTTERY LOCATION
5 COMMISSION UNDER STATE GOVERNMENT ARTICLE, TITLE 9, SUBTITLE 1A.

6 (B) *INCLUSIONS.*

7 “VIDEO LOTTERY FACILITY” INCLUDES:

8 (1) THE PERMITTED NUMBER OF VIDEO LOTTERY TERMINALS;

9 (2) ASSOCIATED FOOD AND BEVERAGE OPERATIONS; AND

10 (3) ASSOCIATED LIVE ENTERTAINMENT AND DANCING.

11 **§ 6-306. {B-2} Permitted uses.**

12 In a B-2 District, permitted uses are as follows:

13 (93) VIDEO LOTTERY FACILITY.

14 **§ 7-306. {M-2} Permitted uses.**

15 In an M-2 District, permitted uses are as follows:

16 (77A) VIDEO LOTTERY FACILITY.

17 **SECTION 2. AND BE IT FURTHER ORDAINED,** That the catchlines contained in this Ordinance
18 are not law and may not be considered to have been enacted as a part of this or any prior
19 Ordinance.

20 **SECTION 3. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the 30th day
21 after the date it is enacted.
