A RESOLUTION ENTITLED

1	A COUNCIL RESOLUTION concerning
2	Erroneous Tax Sale Notices – Special Benefit District Property
3	For the purpose of requesting the Director of Finance and the Chief of the Bureau of Revenue
4	Collections to report to the City Council at a public hearing on what caused many taxpayers
5 6	to receive erroneous tax sale notices and alley paving bills and what procedures can be put in place to avoid this situation in the future.
7	WHEREAS, In 2008, the Baltimore City Finance Department and the Baltimore City Council
8	recognized that the City had failed to apply legitimate and documented property tax credits due
9 10	to Benefit District property owners because of the Benefit District surtax related to their properties; and
11	WHEREAS, Finance applied such credits to all Special Benefit surtaxes in preparing tax bills for fiscal year 2009; and
12	
13	WHEREAS , Due to computer cliches, hundreds of surtax payers were mistakenly mailed overdue tax notices, including property tax sale foreclosure warnings; and
14	
15	WHEREAS, Some of these notices included alley paving charges there had been no prior
16	notification of but that were being cited as a basis for sending the property to tax sale; and
17	WHEREAS, Hundreds of those mistakenly receiving tax sale notices tried to call the phone
18	number listed on their tax sale notices; and
19	WHEREAS, Many of these taxpayers reported "sitting on hold" for hours at a time, only
20	finally to speak with a person who had no knowledge of the tax sale situation and who could not
21	help; and
22	WHEREAS, The alley paving bill was included as part of the notice of the property tax sale,
23	personnel at that number had no knowledge of the alley paving charge and the number they
24	provided the taxpayer was not answered.
25	WHEREAS, The very owners who pay a Property Tax-Plus have now experienced a lengthy
26	"On Hold" response in seeking redress from tax sale mistakes by Baltimore City.

1 2	Now, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE, That Finance explain how these mistaken tax sale notices and alley paving bills were generated and how the
3	phone number listed for inquiry was inadequately staffed and briefed to handle such a deluge of
4	calls.
5	AND BE IT FURTHER RESOLVED, That the Taxation, Finance and Economic Development
6	Committee of the Baltimore City Council be requested to conduct a public hearing to determine
7	how best we can avoid both improper tax sale notices and lengthy "on hold" waits to further
8	avoid such instances.
9	AND BE IT FURTHER RESOLVED, That a copy of this Resolution be sent to the Mayor, the
10	Director of Finance, the Chief of the Bureau of Revenue Collection, the Community
11	Organizations of the Special Benefit Tax Districts, and the Mayor's Legislative Liaison to the
12	City Council.
