## REQUEST: CCB 08-0141 / Zoning - 2103-2105 West North Avenue

For the purpose of permitting, subject to certain conditions, the establishment, maintenance, and operation of a banquet hall on the property known as 2103-2105West North Avenue, as outlined in red on the accompanying plat.

# RECOMMENDATION: Amend and approve. The amendments are listed below:

- The meeting and banquet hall use shall be limited to 2103-2105 West North Avenue;
- The sale of tickets to the general public for live entertainment and dancing events in the meeting and banquet hall is prohibited;
- The uses permitted in the hall shall include events that are catered for: (a) life cycle events (such as Christenings, Confirmations, Bar/Bat Mitzvahs, engagement parties, showers, weddings, birthdays, wakes, family celebrations); (b) fundraising events by or for community and civic associations, government officials, and charitable organizations; (c) events held by private organizations; and (d) conferences and seminars;
- The maximum number of persons allowed in the meeting and banquet hall shall be 250 persons, or may be less as determined by the Baltimore City Fire Department.

### SITE/GENERAL AREA

<u>Site Conditions</u>: The property known as 2103-2105 West North Avenue is improved with a three-story commercial building that is currently used as a restaurant and carryout. The property is zoned B-2-3.
