1 **II. Special Permits and Conditions**

2 **A. Special Permits:**

3 a. The business at 141 W. [hamburg] HAMBURG Street (at the time of this
4 restatement, Jack’s Liquor Store) is eligible for up to 2 special permits[.],
5 [Permits are] valid 7 days a week from [9am-] 9 A.M. TO midnight.

6 b. THE BALTIMORE STATION, 140 W. WEST STREET, IS ELIGIBLE FOR 6 SPECIAL
7 PERMITS, VALID 7 DAYS A WEEK FROM 9 A.M. TO MIDNIGHT.

8 **SECTION 2. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the 30th day
9 after the date it is enacted.
