6	(3) THE NAME AND ADDRESS OF THE APPLICANT; AND
7	(4) HOW ADDITIONAL INFORMATION ON THE MATTER CAN BE OBTAINED.
8	§ 16-5. POSTED NOTICE – NUMBER AND MANNER OF POSTED NOTICES.
9	THE NUMBER OF POSTED NOTICES AND THE MANNER OF THEIR POSTING ARE AS FOLLOWS:
10 11	(1) FOR A NOTICE APPLICABLE ONLY TO AN INDIVIDUAL PROPERTY, AT LEAST 1 SIGN MUST BE VISIBLE FROM EACH OF THE PROPERTY'S STREET FRONTAGES;
12 13 14	(2) FOR A NOTICE APPLICABLE TO MORE THAN 1 PROPERTY (E.G., A MINOR MODIFICATION TO A PLANNED UNIT DEVELOPMENT), AT LEAST 2 OR MORE SIGNS ARE REQUIRED, AS THE DEPARTMENT OF PLANNING DESIGNATES;

20 21	(5) EACH SIGN MUST BE AT LEAST 30" WIDE AND 40" HIGH, BUT NO MORE THAN 4' WIDE OR 5' HIGH;
22 23 24	(6) EACH SIGN MUST BE COMPOSED OF WEATHERPROOF MATERIALS SUFFICIENT TO ENSURE THE SIGN WILL LAST THE REQUIRED POSTING PERIOD (CORRUGATED VINYL AND POLYURETHANE BANNER BEING ACCEPTABLE);

26	(I) FOR THE MAIN HEADLINE, ARIAL BOLD; AND

22 23 24 25	The Department of Planning, with the approval of the City Council of Baltimore, may establish and impose charges for subdivision plans, as defined in Article VII, § 76 of the City Charter, submitted to the Planning Commission for examination and action by it, to defray the cost and expenses incident to said examination and action.
26	(b) When and how paid.
27 28	(1) [Said] THIS charge shall be paid at the time a subdivision plan is first filed with the Department of Planning in the usual course of business.
29 30	(2) Payment may be made either in cash or by certified check, made payable to the Director of Finance of Baltimore.

1	(c) Fee non-refundable.
2 3	[Said] THIS charge [shall] MAY not be refunded in whole or in part, under any circumstances.

9	(c) Minor modifications — design features; interiors.
10	(1) The Planning Commission may authorize minor modifications that:
11	(i) are limited to design features and interior planning; and
12	(ii) do not include any change in the applicable density or bulk regulations.
13 14 15 16 17	(2) The Planning Commission may determine what constitutes a "minor modification" for purposes of this subsection, BUT ONLY IF THE LAW DEPARTMENT HAS REVIEWED THE DETERMINATION AND HAS APPROVED IT IN WRITING FOR COMPLIANCE WITH THE STANDARDS IN PARAGRAPH (1) OF THIS SUBSECTION AND OTHERWISE FOR LEGAL SUFFICIENCY.

22 23 24	SECTION 2. AND BE IT FURTHER ORDAINED , That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.
