AN ORDINANCE CONCERNING

1 **Required Real Estate Disclosures – Formerly Vacant Structures**

2 FOR the purpose of requiring certain disclosures in order to sell a property that was formerly
3 issued a vacant building notice; and providing for certain penalties.

9 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That the
10 Laws of Baltimore City read as follows:

13 **Subtitle 14. Real Estate Practices – Disclosures**

14 **§ 14-7. {RESERVED}**

15 **§ 14-8. FORMERLY VACANT STRUCTURES.**

16 (A) *SCOPE OF SECTION.*

17 **THIS SECTION ONLY APPLIES TO REAL PROPERTY THAT HAS A VACANT BUILDING NOTICE**
18 **THAT REMAINED UNABATED AT THE TIME OF SALE.**

19 ~~(1) HAD BEEN CITED WITH A VACANT BUILDING NOTICE THAT REMAINED UNABATED~~
20 ~~UNTIL THE REHABILITATION DESCRIBED IN THIS SUBSECTION;~~

21 ~~(2) HAS BEEN REHABILITATED IN COMPLIANCE WITH APPLICABLE LOCAL LAWS AND~~

2 ~~(3) HAS NOT BEEN PREVIOUSLY OCCUPIED SINCE THE REHABILITATION.~~

3 (B) *IN GENERAL.*

4 ON OR BEFORE ENTERING INTO A CONTRACT FOR THE SALE OF ANY REAL PROPERTY, THE
5 SELLER MUST DISCLOSE TO THE BUYER IN WRITING THAT:

6 (1) THE PROPERTY HAD BEEN ISSUED A VACANT BUILDING NOTICE BY THE CITY; AND

7 (2) ~~THE NOTICE HAS SINCE BEEN ABATED~~ WHETHER THE VACANT BUILDING NOTICE
8 HAS BEEN ABATED BY THE SELLER OR IF IT REMAINS UNABATED ~~;~~ AND,

9 (3) ~~THE SELLER HAS OBTAINED A VALID AND CURRENT OCCUPANCY PERMIT FOR THE~~
10 ~~PREMISES FROM THE DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT.~~

11 (C) *FORM OF DISCLOSURE.*

12 THE DISCLOSURE REQUIRED BY THIS SECTION SHALL READ AS STATED:

13 FOR SOMEONE TO LEGALLY INHABIT A PROPERTY IN BALTIMORE CITY, THE
14 PROPERTY MUST NOT HAVE A VACANT BUILDING NOTICE ISSUED BY THE
15 BALTIMORE CITY DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT.
16 SELLERS AND BUYERS CAN CHECK AND VERIFY BY REVIEWING THE BALTIMORE
17 CITY CODE MAP: [INSERT LINK], OR BY CALLING BALTIMORE CITY DEPARTMENT
18 OF HOUSING AND COMMUNITY DEVELOPMENT [INSERT PHONE NUMBER].

19 THIS PROPERTY HAS [] DOES NOT HAVE [] A CURRENT VACANT BUILDING
20 NOTICE. _____ SELLER'S INITIALS

21 ONLY A VALIDLY-ISSUED USE AND OCCUPANCY PERMIT CERTIFICATE CAN
22 REMOVE THE VACANT BUILDING NOTICE AND PERMIT HUMAN OCCUPATION.
23 _____ SELLER'S INITIALS

24 (D) ~~(E)~~ *PENALTY.*

25 ANY PERSON WHO VIOLATES ANY PROVISION OF THIS SECTION IS GUILTY OF A
26 MISDEMEANOR AND, ON CONVICTION, IS SUBJECT TO A FINE OF NOT MORE THAN \$1,000
27 FOR EACH OFFENSE.

28 **SECTION 2. AND BE IT FURTHER ORDAINED,** That the catchlines contained in this Ordinance
29 are not law and may not be considered to have been enacted as a part of this or any prior
30 Ordinance.


31 **SECTION 3. AND BE IT FURTHER ORDAINED,** That this Ordinance may not be construed to
32 operate retroactively to require any current property sellers to give the notice created by this
33 Ordinance if an offer for sale of a property has already been accepted.

1 **SECTION 3 4. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the 30th
2 day after the date it is enacted.


