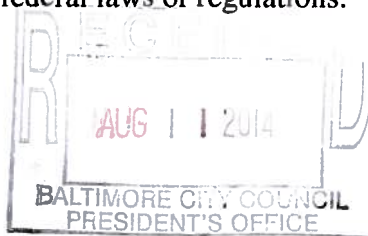

I am herein reporting on **City Council Bill #14-0383**, County Transportation Bonds.

This resolution authorizes the Mayor and the City Council of Baltimore to enter into a Participation Agreement with the Maryland Department of Transportation allowing the City to receive proceeds derived from the sale of the Department of Transportation – County Transportation Revenue Bonds – Series 2014, in the aggregate principal amount not to exceed \$30,500,000.

1. State Transportation Article, Title 3, Subtitle 5 authorizes the Department of Transportation to issue bonds on behalf of the City to provide funds for transportation project (*see enclosed list*). The revenue obligations will be in the form of bonds, issued by the Department of Transportation. The proceeds shall be used to finance (1) the cost of the transportation projects; (2) pay cost of issuance and administration.
2. The Transportation Article requires the local jurisdiction pass this resolution authorizing the transaction and the form participation agreement between the Department of Transportation and the City.
3. The payment of principal and interest shall be secured by a pledge of the City's proportionate share of Highway User Revenues. Each fiscal year the Department of Transportation shall withhold, from the City's share of User Revenues, an amount equal to the debt service requirement. In addition, the Department shall administer the proceeds account and reimburse the City for costs associated with the projects.
4. The participation agreement and repayment of the Bonds shall be a revenue obligation of the City, and is not secured by the full faith and credit of the Mayor and City Council of Baltimore, the State of Maryland, or any other political subdivision of the State of Maryland.
5. The bill does not conflict with existing state or federal laws or regulations.
