19	(1) It [shall be] IS unlawful for any person to loiter at, on, or in a public place or place

23	(ii) to interfere with, obstruct, harass, curse, or threaten or to do physical harm to

29 30	(2) TO COMPLY WITH A REQUEST TO MOVE ON, THE PERSON MUST MOVE AT LEAST 500 FEET FROM THE BUS STATION OR RAILROAD STATION.

29 30 31 32 33 34 35	It shall be unlawful for any person [or persons,] who [are] IS remaining, standing, loitering, or wandering about at any public place or place open or legally accessible to the public in such a manner as to beckon to, or repeatedly stop, or repeatedly attempt to engage passersby in conversation, or repeatedly stop or attempt to stop motor vehicles, or repeatedly interfere with the free passage of other persons, for the purpose or with the intention of either engaging in [and/or] OR promoting prostitution, lewdness, or assignation, to disobey a request by a police officer to move on.
