12	Recitals
13 14 15	The revenue appropriated by this Ordinance represents \$250,323 in excess of the revenue relied on by the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2024.
16 17	This additional revenue could not have been reasonably anticipated when the Ordinance of Estimates for Fiscal Year 2024 was formulated.
18	The source of this additional revenue is Income Tax - State Collected.
19 20 21	This appropriation is made necessary by a material change in circumstances since the Ordinance of Estimates for Fiscal Year 2024 was formulated or is for a new program that could not have been reasonably anticipated when that Ordinance of Estimates was formulated.
22 23	On February 5, 2025, the Board of Estimates recommended this appropriation to the City Council.

1	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That
2	\$250,323 shall be made available to the Liquor License Board – Service 850 (Liquor Licensing)
3	as a Supplementary Special Revenue General Fund Operating Appropriation for Fiscal Year
4	2024, to provide funding for overtime for inspectors beyond budget; state salary adjustments for
5	full-time positions. The source of revenue for this appropriation is Income Tax - State Collected
5	in excess of the amount from this source that was relied on by the Board of Estimates in
7	determining the tax levy required to balance the budget for Fiscal Year 2024.

SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it is enacted.
