1 AN ORDINANCE concerning

2 **Supplementary General Fund Operating Appropriation –**
3 **MR-Civic Promotion – \$250,000**

4 FOR the purpose of providing a Supplementary General Fund Operating Appropriation in the
5 amount of \$250,000 to the MR-Civic Promotion – Program 590 (Civic Promotion), to
6 provide funding for the purchase of vehicles and equipment for the Maryland Food Bank;
7 and providing for a special effective date.

13 **Recitals**

14 The revenue appropriated by this Ordinance represents funds from the Fiscal 2006 Fund
15 Balance in excess of the revenue relied on by the Board of Estimates in determining the tax levy
16 required to balance the budget for Fiscal Year 2007.

17 This additional revenue could not have been reasonably anticipated when the Ordinance of
18 Estimates for Fiscal Year 2007 was formulated.

19 This appropriation is made necessary by a material change in circumstances since the
20 Ordinance of Estimates for Fiscal Year 2007 was formulated or is for a new program that could
21 not have been reasonably anticipated when that Ordinance of Estimates was formulated.

22 On August 9, 2006, the Board of Estimates recommended this appropriation to the City
23 Council.

24 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That
25 \$250,000 shall be made available to the MR-Civic Promotion – Program 590 (Civic Promotion)
26 as a Supplementary General Fund Operating Appropriation for Fiscal Year 2007, to provide
27 funding for the purchase of vehicles and equipment for the Maryland Food Bank. The source of
28 revenue for this appropriation is from the Fiscal 2006 Fund Balance in excess of the amount

1 from this source that was relied on by the Board of Estimates in determining the tax levy
2 required to balance the budget for Fiscal Year 2007.

3 **SECTION 2. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the date it
4 is enacted.
