15	the C-1 Zoning District the properties known as 1801 to 1807 Bloomingdale Road (Block 2427,
16	Lots 032 to 035) and 1800 to 1816 North Rosedale Street (Block 2427, Lots 001 to 009), as
17	outlined in red on the plat accompanying this Ordinance.

19	accompanying plat and in order to give notice to the agencies that administer the City Zoning
20	Ordinance: (i) when the City Council passes this Ordinance, the President of the City Council

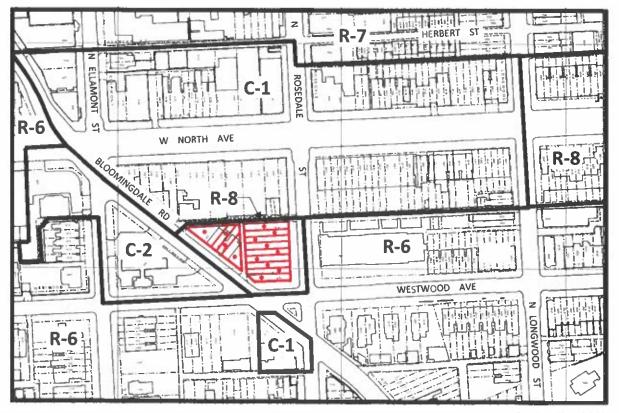

SHEET NO. 43 OF THE ZONING MAP OF THE ZONING CODE OF BALTIMORE CITY

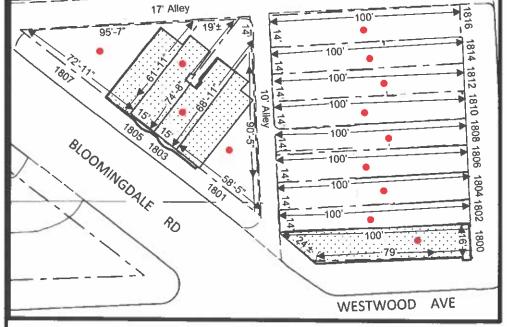
