Legislative note: Article III, § 7(b) of the City Charter establishes a 60-day period during which the City Council may: (i) adopt or amend the Mayor's redistricting plan; or (ii) adopt another plan. Council Bill 23-0428 was introduced and read for the first time on September 18, 2023. The expiration of the 60-day period was November 17, 2023. Council Bill 23-0428, as amended, was passed by the City Council and sent to the Mayor for his signature or veto on October 19, 2023. The Mayor vetoed the Council's amended version of Council Bill 23-0428 on November 6, 2023. Article III, § 7(b) of the City Charter states that "[i]f no [redistricting] plan has been adopted by the City Council within sixty days after the Mayor's plan is presented, the Mayor's plan shall take effect as the redistricting ordinance." City Charter, Article IV, § 5 dictates that the Council may only override a Mayoral veto at a regularly scheduled meeting. Because of the timing of the Mayor's veto there were no available regularly scheduled meetings that fell within the 60-day period during which the Council may have taken up a veto override vote. Consequently, because there was no time left within the 60-day period for an override, the Mayor's redistricting plan took effect. This enrolled copy of Council Bill 23-0428 is a facsimile of the redistricting plan originally presented by the Mayor. By effect of the City Charter this enrolled Council Bill now is the effective redistricting plan for the City of Baltimore as of November 17, 2023.
