1	(C) [(b)] Motor fuel.
2	[The term "motor fuel" shall mean:]
3	"MOTOR FUEL" MEANS:
4	(1) a light distillate of petroleum or allied substance with suitable volatility and other
5 6	characteristics to be used as a fuel for operating internal combustion engines whether or not it is mixed with other materials; or
7 8	(2) any other product or liquid when sold for use as a fuel in any type of internal combustion engine furnishing power to operate a motor vehicle.
9	(D) RETAIL DEALER.
10	"RETAIL DEALER" MEANS ANY PERSON, FIRM, OR CORPORATION OPERATING A SERVICE
11	STATION, FILLING STATION, STORE, GARAGE, OR OTHER PLACE OF BUSINESS FOR THE

16	§ 10-4. Signs.
17	(a) Legislative finding.
18	The City Council finds that the preservation of the natural beauty of Baltimore City
19	requires the limitation of signs advertising prices of motor vehicle fuels at places
20	dispersing fuels in Baltimore City. Such limitation will equally serve to protect the safety
21	and recreational value of public travel on streets in the City and will better protect the
22	public investment in its streets and highways. In furtherance of these purposes, the
23	following limitations are enacted.
24	(b) Price signs on pumps.
25	(1) Every retail dealer in motor fuel shall publicly display and maintain on each pump or
26	other dispensing device, from which motor fuel is sold by him, at least 1 sign and not
27	more than 2 signs stating the price per gallon of the motor fuel, the State and Federal
28	taxes, and the total price, sold by him from such pump or device.
29	(2) Said sign or signs shall be of a size not larger than 8 inches by 10 inches.
30	(3) The price shown on each of such signs shall include an itemization of the cost per
31	gallon of said motor fuel, the amount of Federal taxes, and the amount of State taxes.
32	(4) All figures, including fractions, upon said signs, other than figures and fractions used
33	in any price-computing mechanism constituting a part of any such pump or dispensing
34	device, shall be of the same size

1	(C) CREDIT PRICE MUST BE DISPLAYED.
2 3 4	If a retail dealer in motor fuel posts a sign under \S 10-315(e) of the State Business Regulation Article, the sign must include, clearly and visibly, the highest credit price.
5	(D) [(c)] Other price signs prohibited.
6 7 8 9 10 11	No signs stating or relating to the prices of motor fuel and no signs designed or calculated to cause the public to believe that they state or relate to the price of motor fuel, other than the signs referred to in [subsection (b)] SUBSECTIONS (B) AND (C) of this section and required to be displayed upon pumps and other dispensing devices, shall be posted or displayed on or about the premises where motor fuel is sold at retail, and within the view of any public highway or reservation.

13	(a) In general.
14 15 16	(1) Except as provided under [subsection (b)] SUBSECTIONS (B) AND (C) of this section, whoever, himself or by his agent or servant, violates any provision of this subtitle shall be punished by a fine of not less than \$10 nor more than \$100.
17 18 19 20	(2) Upon the 2nd conviction of any licensee or any such violation, whether by himself or by his agent or servant, the Director of Finance may suspend the right of such licensee to engage in the business of selling motor fuel at retail for a period not exceeding 3 months.
21 22 23	(3) Upon a 3rd or subsequent conviction of any license of any such violation, whether by himself or by his agent or servant, the Director of Finance may suspend such right for a period not exceeding 1 year.
24	(B) VIOLATIONS OF § $10-4(C)$.
25 26	Any retail dealer of motor fuel violating \S 10-4(c) of this subtitle is subject to:
27	(I) FOR A FIRST OFFENSE, A FINE OF NOT MORE THAN \$100;
28	(II) FOR A SECOND OFFENSE, A FINE OF NOT MORE THAN \$250;
29	(III) FOR A THIRD OFFENSE, A FINE OF NOT MORE THAN $$500$; AND
30 31 32	(IV) FOR A FOURTH OR SUBSEQUENT OFFENSE, A FINE OF NOT MORE THAN \$1,000 AND THE SUSPENSION OF THE RETAIL DEALER'S LICENSE UNDER § $10-2$ OF THIS SUBTITLE.

2 3	Any retail service station dealer who is convicted of a violation of any provision of § 10-6 of this subtitle is subject to a fine of not more than \$25.
4 5	SECTION 2. AND BE IT FURTHER ORDAINED , That this Ordinance takes effect on the 30 th day after the date it is enacted.
