A BILL ENTITLED

1 AN ORDINANCE concerning

2 **Acquisition of Property – Baltimore Red Line Transit Project**

3 FOR the purpose of authorizing the Mayor and City Council of Baltimore to acquire, by purchase  
4 or condemnation, the fee simple or other interests in certain property or portions of property,  
5 together with all right, title, interest, and estate that the owner or owners of the property have  
6 in all streets, alleys, ways, or lanes, public or private, contained within or abutting the whole  
7 area described or contained within the perimeter of the area, being situated in Baltimore City,  
8 and needed for the Baltimore Red Line Transit Project; and providing for a special effective  
9 date.

22 **Recitals**

23 Whereas, the Baltimore Red Line is a 14.1 miles light rail transit project  
24 with major elements, including 4 miles of tunnel, dedicated and fixed  
25 guideway, and 19 stations, 5 of which will be underground; and

26 Whereas, the Baltimore Red Line will provide critical east-west  
27 connectivity lacking in Baltimore’s current rail transit system; and

EXPLANATION: CAPITALS indicate matter added to existing law.  
[Brackets] indicate matter deleted from existing law.

1           Whereas, through its Comprehensive Master Plan, the Red Line  
2           Community Compact, the adoption of a Memorandum of Understanding  
3           approved by the Board of Estimates on October 24, 2012, and through  
4           other means and actions, the Mayor and City Council of Baltimore has  
5           agreed to own and acquire certain property necessary for the Red Line; and

6           Whereas, Chapter 2 of the Acts of the 2006 Special Session of the General  
7           Assembly, as amended by Chapter 570 of the 2009 Acts of the General  
8           Assembly, as further amended by Chapter 360 of the 2013 Acts of the  
9           General Assembly, prohibits the City of Baltimore or the Maryland Transit  
10          Administration from acquiring any real property for construction of the  
11          Red Line transit project, if the acquisition would result in involuntary  
12          residential displacement; and

13          Whereas, on February 28, 2013, the Federal Transit Administration  
14          granted a Record of Decision of the Red Line's Final Environmental  
15          Impact Statement; and

16          Whereas, in order for the Maryland Transit Administration to secure final  
17          approval to advertise the Red Line for construction, federal law requires  
18          that the Maryland Transit Administration demonstrate "satisfactory  
19          continuing control", such as fee simple ownership, perpetual easement,  
20          and other property interests for all property necessary to construct and  
21          operate the line.

22           **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That it is  
23          necessary to acquire, for the Red Line Project, the fee simple or other interests in property within  
24          the Red Line Corridor, attached as Exhibit A, that the Commissioner of Housing and Community  
25          Development considers needed for the Project that is located within the Red Line Corridor,  
26          together with all right, title, interest, and estate that the owner or owners of the property have in  
27          all streets, alleys, ways, or lanes, public or private, contained within or abutting the whole area  
28          described or contained within the perimeter of the area, being situated in Baltimore City, and  
29          needed for the Baltimore Red Line Transit Project.

30           **SECTION 2. AND BE IT FURTHER ORDAINED,** That it may be necessary to acquire by purchase  
31          or by condemnation the fee simple interest or lesser interest in and to properties or portions of  
32          properties along the Red Line alignment not specifically designated for acquisition on Exhibit A,  
33          or as may be deemed necessary and proper by the Commissioner of Housing and Community  
34          Development, in order to carry out the implementation of the Red Line Transit Project.

35           **SECTION 3. AND BE IT FURTHER ORDAINED,** That nothing in the detailed property  
36          description provided in the attached Exhibit A shall limit the Commissioner's authority to  
37          acquire property interests in addition to those that are listed in Exhibit A, provided that:

- 38           (a) the acquisition has been determined by the Commissioner of Housing and Community  
39          Development as necessary for the construction and operation of the Red Line in  
40          Baltimore City and as the acquisition is necessary for the health, safety, or welfare of  
41          the public; and

1 (b) notification is made to the Councilmember in the Councilmanic District in which the  
2 acquisition will occur.

3 **SECTION 4. AND BE IT FURTHER ORDAINED,** That the Department of Real Estate, or any  
4 other person or agency that the Board of Estimates designates, may negotiate and acquire on  
5 behalf of the Mayor and City Council of Baltimore the fee simple or other interests in the land  
6 and improvements described in this Ordinance as needed for the purposes described in this  
7 Ordinance. If the Department of Real Estate, or the person or agency otherwise designated by the  
8 Board of Estimates, is unable to agree with the owner on the purchase price for the property, it  
9 shall promptly notify the City Solicitor, who shall institute the necessary legal proceedings to  
10 acquire by condemnation the fee simple or other interests needed or sufficient for the purposes  
11 described in this Ordinance.

12 **SECTION 5. AND BE IT FURTHER ORDAINED,** That proceedings for the acquisition by  
13 condemnation of the property described in this Ordinance and all rights of all parties interested or  
14 affected shall be in accordance with Title 12 of the Real Property Article of the Maryland Code  
15 and Title 12 of the Maryland Rules.

16 **SECTION 6. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the date it is  
17 enacted.
