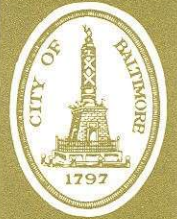

City Council Bill Number 13-0234, Harbor Point Bond Ordinance, provides for the issuance of special obligation bonds or notes in an amount not exceeding \$125,000,000. The Bill also provides a pledge by the City of tax increment revenues and special tax revenues, subject to appropriation, to the payment of debt service on the special obligation bonds. The purpose of the bonds is to finance public improvements in the Harbor Point Development District and other such related development and administrative costs permitted under the act.

The Board of Finance has considered and approved the Special Obligation Bond request for this purpose on May 20, 2013; and approved the submission of this legislation to the President and Members of the City Council of Baltimore.

The Finance Department recommends favorable consideration and passage of this legislation.
