  - SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That, in accordance with Article V, § 5(b) of the City Charter, the City Comptroller may sell, at either public or private sale, all the interest of the Mayor and City Council of Baltimore in a certain parcel of land known as the subterranean rights under <u>East</u> Pleasant Street, 23.35 feet east of St. Paul Place and extending Easterly 26.00 feet, and more particularly described as follows:

Beginning for the same at a point on the north side of <u>East</u> Pleasant Street, 49.5 feet wide, distant North 86° 44' 00" East 23.35 feet, measured along the north side of said <u>East</u> Pleasant Street from the east side of St. Paul Place, 54 feet wide, and at a horizontal plane having an elevation of 33.00 feet and descending to an elevation of unlimited depth, and running thence binding on the north side of said <u>East</u> Pleasant Street, North 86° 44' 00" East 26.00 feet; thence by a straight line drawn at a right angle to the north side of said <u>East</u> Pleasant Street, South 03° 16' 00" East 49.50 feet to intersect the south side of said <u>East</u> Pleasant Street; thence binding on the south side of said <u>East</u> Pleasant Street, South 86° 44' 00" West 26.00 feet, and thence by a straight line drawn at a right angle to the south side of said <u>East</u> Pleasant Street, North 03° 16' 00" West 49.50 feet to the place of beginning.
