13	parcel of land known as Block 6254D, Lot 021, and more particularly described as follows:		
14	This unimproved parcel of land is shown as Lot 021 on the Final Subdivision Plan		
15	of 140 N. Janney Street, dated January 30, 2017, as recorded in the MD Land		
16	Records for the City of Baltimore, Plat MB 4294.		
17	Containing 78,317 square feet, more or less, or 1.481 acres, more or less.		
18	Subject to full width perpetual easements for all municipal utilities and services, not to be		
19	abandoned, over the entire hereinabove described parcel of land.
