**AN ORDINANCE CONCERNING**

**Bond Issue - Community Development Loan - \$24,000,000**

2           **Bond Issue - Community Development Loan - \$24,000,000**  
3           FOR the purpose of authorizing the Mayor and City Council of Baltimore (pursuant to Resolution  
4           III of 2012 approved by the members of the Maryland General Assembly representing  
5           Baltimore City) to create a debt, and to issue and sell its certificates of indebtedness as  
6           evidence thereof, and proceeds not exceeding \$24,000,000 from the sale of such certificates  
7           of indebtedness to be used for the cost of issuance, including the expense of engraving,  
8           printing, advertising, attorneys' fees, and all other incidental expenses connected therewith,  
9           and the remainder of such proceeds to be used for or in connection with planning,  
10          developing, executing, and making operative the community development program of the  
11          Mayor and City Council of Baltimore, including, but not limited to, the acquisition, by  
12          purchase, lease, condemnation or any other legal means, of land or property, or any right,  
13          interest, franchise, easement or privilege therein, in the City of Baltimore; the payment of any  
14          and all costs and expenses incurred in connection with or incidental to the acquisition and  
15          management of said land or property, including any and all rights or interests therein  
16          hereinbefore mentioned; the development, or redevelopment, including, but not limited to,  
17          the comprehensive renovation or rehabilitation of any land or property, or any rights or  
18          interests therein hereinbefore mentioned, in the City of Baltimore, and the disposition of land  
19          and property for such purposes; the elimination of unhealthful, unsanitary, or unsafe  
20          conditions, lessening density, eliminating obsolete or other uses detrimental to the public  
21          welfare or otherwise removing or preventing the spread of blight or deterioration in the City  
22          of Baltimore and the creation of healthy, sanitary, and safe, and green conditions in the City  
23          of Baltimore; the demolition, removal, relocation, renovation or alteration of land, buildings,  
24          streets, highways, alleys, utilities or services, and other structures or improvements, and for  
25          the construction and reconstruction, installation, relocation or repair of buildings, streets,  
26          highways, alleys, utilities or services, and other structures or improvements; the payment of  
27          any and all costs and expenses incurred for or in connection with doing any or all of the  
28          things herein mentioned, including, but not limited to, the costs and expenses of securing  
29          administrative, appraisal, economic analysis, engineering, planning, designing, architectural,  
30          surveying, and other professional services; and the lending or granting of funds to any person  
31          or other legal entity to be used for or in connection with the rehabilitation, renovation,  
                redevelopment, improvement or construction of buildings and structures located within the

1 boundaries of Baltimore City, which buildings or structures are to be used or occupied for  
2 residential or commercial purposes; and doing any and all things necessary, proper or  
3 expedient in connection with or pertaining to any or all of the matters or things hereinbefore  
4 mentioned; all such land or property shall be acquired, developed, redeveloped, renovated,  
5 rehabilitated, altered, improved, held or disposed of, as provided by law; authorizing the  
6 issuance of refunding bonds; conferring and imposing upon the Board of Finance of  
7 Baltimore City certain powers and duties; authorizing the submission of this Ordinance to the  
8 legal voters of the City of Baltimore, for their approval or disapproval, at the General  
9 Election to be held in Baltimore City, on Tuesday, the 6<sup>th</sup> day of November, 2012; and  
10 providing for the expenditure of the proceeds of sale of said certificates of indebtedness in  
11 accordance with the provisions of the Charter of the Mayor and City Council of Baltimore,  
12 and by the municipal agency designated in the annual Ordinance of Estimates of the Mayor  
13 and City Council of Baltimore.

14 **WHEREAS**, By Resolution III of 2012, approved by the members of the Maryland General  
15 Assembly representing Baltimore City, the Mayor and City Council of Baltimore is authorized to  
16 create a debt and to issue and sell its certificates of indebtedness (hereinafter called "bonds") as  
17 evidence thereof, and proceeds not exceeding \$24,000,000 from the sale of such bonds to be used  
18 in connection with the community development program of the Mayor and City Council of  
19 Baltimore as authorized by said Resolution; and

20 **WHEREAS**, Funds are now needed for said purposes; now, therefore,

21 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE**, That the  
22 Mayor and City Council of Baltimore, acting by and through the Board of Finance of said  
23 municipality, be and it is hereby authorized and empowered to create a debt and to issue and sell  
24 bonds of the Mayor and City Council of Baltimore from time to time, as may be needed or  
25 required for the purposes hereinafter named and said bonds shall be sold by the Board of Finance  
26 from time to time and at such times as shall be requisite, and proceeds not exceeding  
27 \$24,000,000 from the sale of such bonds shall be used for the purposes hereinafter named,  
28 provided that this Ordinance shall not become effective unless it shall be approved by a majority  
29 of the votes of the legal voters of Baltimore City cast at the time and place hereinafter designated  
30 by this Ordinance.

31 **SECTION 2. AND BE IT FURTHER ORDAINED**, That:

32 (a) The denomination or denominations of the bonds to be issued at any particular time  
33 and the place or places for the payment of principal and interest thereof are to be determined by  
34 the Board of Finance.

35 (b) The bonds authorized to be issued and sold under the provisions of this Ordinance  
36 may be issued to mature on such dates and in such amounts as the Board of Finance may  
37 determine; provided that the entire principal amount represented thereby shall be discharged not  
38 more than 40 years from the date of issuance of the bonds.

39 (c) The bonds, when issued, shall bear interest at such rate or rates as may be determined  
40 by the Board of Finance, which rate or rates may be fixed or variable or as determined by a  
41 method approved by the Board of Finance, and such interest shall be payable at such time or  
42 times as may be determined by the Board of Finance.

1       **SECTION 3. AND BE IT FURTHER ORDAINED,** That a majority of the Board of Finance of the  
2 Mayor and City Council of Baltimore be, and they are hereby, authorized to pass a resolution or  
3 resolutions, from time to time, to determine and set forth any or all of the following:

4           (a) The amount of debt to be incurred by the Mayor and City Council of Baltimore at any  
5 particular time, and from time to time, under and pursuant to the provisions of this Ordinance;  
6 the date or dates when any bonds representing said debt, or any part thereof, are to mature, and  
7 the amount or amounts of said debt, or any part thereof, which shall mature upon the aforesaid  
8 date or dates; and the date or dates in each year, during the entire period of time when any of said  
9 bonds are outstanding, when interest on any of said bonds shall be payable;

10          (b) The form or forms of the bonds representing the debt, or any part thereof, authorized  
11 to be issued under the provisions of this Ordinance at any particular time; and

12          (c) If the bonds are to be sold at public sale, the time, place, manner and medium of  
13 advertisement of the readiness of the Board of Finance, acting for and on behalf of the Mayor and  
14 City Council of Baltimore, to receive bids for the purchase of the bonds authorized to be issued  
15 hereunder or any part thereof; the form, terms and conditions of such bids; the time, place and  
16 manner of awarding bonds so bid for, including the right whenever any of the bonds authorized  
17 by this Ordinance are offered for sale and sold at the same time as other bonds of the City, to  
18 establish the conditions for bids and awards and to award all of the bonds on an all or none basis,  
19 and the time, place, terms and manner of settlement for the bonds so bid for; provided, however,  
20 that notwithstanding anything in this section, the Mayor and City Council of Baltimore, or the  
21 Board of Finance, as the case may be, shall have the right to reject any or all bids therefor for any  
22 reason.

23       **SECTION 4. AND BE IT FURTHER ORDAINED,** That:

24           (a) All premiums resulting from the sale of any of the bonds issued and sold pursuant to  
25 the provisions of this Ordinance shall be applied as directed by the Board of Finance.

26           (b) The debt authorized by the provisions of this Ordinance, and the bonds issued and  
27 sold pursuant thereto and their transfer, and the principal and interest payable thereon (including  
28 any profit made in the sale thereof), shall be and remain exempt from any and all State, county  
29 and municipal taxation in the State of Maryland.

30           (c) All bonds issued and sold pursuant to the provisions of this Ordinance may be sold at  
31 public sale by the solicitation of competitive bids or at private (negotiated) sale without  
32 advertisement or solicitation of competitive bids, for a price or prices which may be at, above or  
33 below par value of the bonds, as determined by resolution of the Board of Finance of the Mayor  
34 and City Council of Baltimore.

35       **SECTION 5. AND BE IT FURTHER ORDAINED,** That until all of the interest on and principal of  
36 any bonds issued pursuant to the provisions of this Ordinance have been paid in full, the Mayor  
37 and City Council of Baltimore shall levy and impose an annual tax on each \$100 of assessable  
38 property in the City of Baltimore at a rate sufficient to produce revenue to pay all interest on and  
39 principal of all bonds theretofore issued and outstanding or authorized to be issued and  
40 outstanding, payable in the next succeeding year.

1       **SECTION 6. AND BE IT FURTHER ORDAINED**, That this Ordinance shall be submitted to the  
2 legal voters of the City of Baltimore, for their approval or disapproval, at the General Election to  
3 be held in Baltimore City, on Tuesday, the 6<sup>th</sup> day of November, 2012.

4       **SECTION 7. AND BE IT FURTHER ORDAINED**, That prior to the date of the election  
5 hereinbefore mentioned, notice shall be given to the public of the amount of money which the  
6 Mayor and City Council of Baltimore is authorized to borrow, and the general purposes for  
7 which such borrowed funds may be expended, under the terms and provisions of this Ordinance,  
8 and the time when the election hereinbefore mentioned is to be held; and such public notice shall  
9 be given in such manner and by such means or through such media and at such time or times as  
10 may be determined, from time to time, by a majority of the Board of Finance.

11       **SECTION 8. AND BE IT FURTHER ORDAINED**, That the actual cash proceeds derived from the  
12 sale of the bonds authorized to be issued under the provisions of this Ordinance shall be used  
13 exclusively for the following purposes, to wit:

14           (a) So much thereof as may be necessary for the cost of issuance, including the expense of  
15 engraving, printing, advertising, attorneys' fees, and all other incidental expenses connected  
16 therewith (which may include the proportion of the compensation of employees and general  
17 administrative expenses of the Department of Finance reasonably allocated to the issuance of the  
18 bonds); and

19           (b) The remainder of such proceeds shall be used for or in connection with planning,  
20 developing, executing and making operative the community development program of the Mayor  
21 and City Council of Baltimore, including, but not limited to:

22                   (i) The acquisition, by purchase, lease, condemnation, or any other legal means, of  
23 land or property, or any right, interest, franchise, easement or privilege therein, in the City of  
24 Baltimore;

25                   (ii) The payment of any and all costs and expenses incurred in connection with or  
26 incidental to the acquisition and management of said land or property, including any and all  
27 rights or interests therein hereinbefore mentioned;

28                   (iii) The development or redevelopment, including, but not limited to, the  
29 comprehensive renovation or rehabilitation of any land or property, or any rights or interests  
30 therein hereinbefore mentioned, in the City of Baltimore, and the disposition of land and property  
31 for such purposes;

32                   (iv) The elimination of unhealthful, unsanitary, or unsafe conditions, lessening  
33 density, eliminating obsolete or other uses detrimental to the public welfare or otherwise  
34 removing or preventing the spread of blight or deterioration in the City of Baltimore and the  
35 creation of healthy, sanitary, and safe, and green conditions in the City of Baltimore;

36                   (v) The demolition, removal, relocation, renovation or alteration of land, buildings,  
37 streets, highways, alleys, utilities or services, and other structures or improvements, and for the  
38 construction and reconstruction, installation, relocation or repair of buildings, streets, highways,  
39 alleys, utilities or services, and other structures or improvements;

1 (vi) The payment of any and all costs and expenses incurred for or in connection with  
2 doing any or all of the things herein mentioned, including, but not limited to, the costs and  
3 expenses of securing administrative, appraisal, economic analysis, engineering, planning,  
4 designing, architectural, surveying, and other professional services; and

5 (vii) The lending or granting of funds to any person or other legal entity to be used for  
6 or in connection with the rehabilitation, renovation, redevelopment, improvement or construction  
7 of buildings and structures located within the boundaries of Baltimore City, which buildings or  
8 structures are to be used or occupied for residential or commercial purposes; and

9 (viii) Doing any and all things necessary, proper or expedient in connection with or  
10 pertaining to any or all of the matters or things hereinbefore mentioned.

11 All such land or property shall be acquired, developed, redeveloped, renovated,  
12 rehabilitated, altered, improved, held or disposed of, as provided by law.

### 13 SECTION 9. AND BE IT FURTHER ORDAINED, That:

14 (a) The Mayor and City Council of Baltimore, acting by and through the Board of Finance  
15 thereof, is hereby authorized and empowered to issue its bonds for the purpose of refunding any  
16 bonds authorized to be issued under the provisions of this Ordinance by payment at maturity or  
17 the purchase or redemption of bonds in advance of maturity. The validity of any refunding bonds  
18 shall in no way be dependent upon or related to the validity or invalidity of the bonds being  
19 refunded. Such refunding bonds may be issued by the Mayor and City Council of Baltimore,  
20 acting by and through the Board of Finance thereof, for the purpose of providing it with funds to  
21 pay any of its outstanding bonds authorized to be issued under the provisions of this Ordinance at  
22 maturity, to purchase in the open market any of its outstanding bonds authorized to be issued  
23 under the provisions of this Ordinance prior to their maturity, to redeem prior to their maturity  
24 any outstanding bonds which are, by their terms, redeemable, to pay interest on any outstanding  
25 bonds prior to their payment at maturity or purchase or redemption in advance of maturity, or to  
26 pay any redemption or purchase premium in connection with the refunding of any of its  
27 outstanding bonds authorized to be issued under the provisions of this Ordinance.

28 (b) Any refunding bonds authorized to be issued and sold under the provisions of this  
29 Ordinance may be issued for the public purpose of:

30 (1) Realizing savings to Baltimore City in the aggregate cost of debt service on either  
31 a direct comparison or present value basis; or

32 (2) Debt restructuring that:

33 (i) In the aggregate effects such a reduction in the cost of debt service; or

34 (ii) Is determined by the Board of Finance of the Mayor and City Council of  
35 Baltimore to be in the best interests of Baltimore City, to be consistent with Baltimore City's  
36 long-term financial plan, and to realize a financial objective of Baltimore City including,  
37 improving the relationship of debt service to a source of payment such as taxes, assessments, or  
38 other charges.

1 (c) Any refunding bonds authorized to be issued and sold under the provisions of this  
2 Ordinance may be issued in whatever principal amount shall be required to achieve the purpose  
3 for the issuance of the refunding bonds, which amount may be in excess of the principal amount  
4 of the bonds refunded or the maximum principal amount of bonds authorized to be issued under  
5 Section 1 of this Ordinance.

6 (d) Any refunding bonds authorized to be issued and sold under the provisions of this  
7 Ordinance may be issued to mature on such dates and in such amounts as the Board of Finance  
8 may determine; provided that the entire principal amount represented by the refunding bonds  
9 shall be discharged not more than 40 years from the date of issuance of the bonds being refunded.

10 (e) Any refunding bonds authorized to be issued and sold under the provisions of this  
11 Ordinance may be sold at public sale by the solicitation of competitive bids or at private  
12 (negotiated) sale without advertisement or solicitation of competitive bids, for a price or prices  
13 which may be at, above or below the par value of the refunding bonds, as determined by  
14 resolution of the Board of Finance of the Mayor and City Council of Baltimore.

15 (f) Any refunding bonds authorized to be issued and sold under the provisions of this  
16 Ordinance shall bear interest at such rate or rates as may be determined by the Board of Finance  
17 of the Mayor and City Council of Baltimore, which rate or rates may be fixed or variable or as  
18 determined by a method approved by the Board of Finance, and such interest shall be payable at  
19 such time or times as may be determined by the Board of Finance.

20 (g) The proceeds of the sale of any refunding bonds authorized to be issued and sold  
21 under the provisions of this Ordinance, after the payment of issuance costs relating thereto, shall  
22 be set aside by the Mayor and City Council of Baltimore as a separate trust fund to be used solely  
23 for the purposes stated in this Section 9.

24 (h) Except as otherwise provided in this Section 9, the powers granted in, the limitations  
25 and obligations imposed by, and the procedures specified in this Ordinance with respect to the  
26 issuance of bonds shall be applicable to the issuance of refunding bonds.

27 (i) Any refunding bonds authorized to be issued and sold under the provisions of this  
28 Ordinance shall not be subject to any debt policy limitation that may from time to time be  
29 established by the Mayor and City Council of Baltimore.

30 **SECTION 10. AND BE IT FURTHER ORDAINED,** That the expenditure of the proceeds derived  
31 from the sale of the bonds authorized to be issued under the provisions of this Ordinance shall be  
32 in accordance with the provisions of the Charter of the Mayor and City Council of Baltimore, and  
33 by the municipal agency designated in the annual Ordinance of Estimates of the Mayor and City  
34 Council of Baltimore.
