      - Where are you with this?
    - o Wellness Program
      - How are you reaching out to the employees?
    - Vacancies
      - Concern: Vacancies getting filled in a timely manner
    - o Labor Commissioner
      - No questions asked and/or concerns stated by committee/councilmembers
  - Department of General Services
    - o Before Ms. Nyaga-Nash gave her presentation, she talked about some of the accomplishments of the Department and about the effects of the pandemic.

  - This program should have been sent to the MOED did anyone think about this?
- Landscaping Management
  - Comments regarding opportunities being available for MBE/WBE participation
- Performance of Sub-Contractors
  - Performance is poor and cannot be unnoticed
  - Grade of material used is of concern
  - Comments regarding the scarcity of dollars for capital projects
- Circulators
  - In terms of equity, are you considering expanding the service?
- o Traffic Calming
  - It seems to be a backlog for traffic calming, can you talk about how your department can "beef up" the backlog?
- o Bike Lanes
  - What type of equity lens are you using for bike lanes?
