AN ORDINANCE CONCERNING

Bond Issue — Walters Art Museum Loan — \$300,000

2 FOR the purpose of authorizing the Mayor and City Council of Baltimore (pursuant to Resolution
3 VII of 2012 approved by the members of the Maryland General Assembly representing
4 Baltimore City) to create a debt, and to issue and sell its certificates of indebtedness as
5 evidence thereof, and proceeds not exceeding \$300,000 from the sale of such certificates to
6 be used for the cost of issuance, including the expense of engraving, printing, advertising,
7 attorneys' fees, and all other incidental expenses connected therewith, and the remainder of
8 such proceeds shall be used for the Walters Art Museum, including but not limited to, the
9 acquisition by purchase, lease, condemnation or any other legal means, of land or property, or
10 any rights therein, in the City of Baltimore, and constructing and erecting on said land or
11 property, or on any land or property, new buildings, structures, and other auxiliary facilities;
12 and for the renovation, alteration, construction, reconstruction, installation, improvement and
13 repair of existing buildings, structures or facilities, to be or now being used for or in
14 connection with the operations, functions, and activities of the Walters Art Museum; and for
15 equipment for any and all facilities authorized to be constructed, renovated, altered or
16 improved by the provisions hereof; the payment of any and all costs and expenses incurred
17 for or in connection with doing any or all of the things herein mentioned, including but not
18 limited to the costs and expenses of securing administrative, appraisal, economic analysis,
19 engineering, planning, designing, architectural, surveying and other professional services; and
20 for doing any and all things necessary, proper or expedient in connection with or pertaining to
21 any or all of the matters or things hereinbefore mentioned; authorizing the issuance of
22 refunding bonds; conferring and imposing upon the Board of Finance of Baltimore City
23 certain powers and duties; authorizing the submission of this Ordinance to the legal voters of
24 the City of Baltimore, for their approval or disapproval, at the General Election to be held in
25 Baltimore City on Tuesday, the 6th day of November, 2012; and providing for the expenditure
26 of the proceeds of sale of said certificates of indebtedness in accordance with the provisions
27 of the Charter of the Mayor and City Council of Baltimore, and by the municipal agency
28 designated in the annual Ordinance of Estimates of the Mayor and City Council of Baltimore.

29 **WHEREAS**, By Resolution VII of 2012, approved by the members of the Maryland General
30 Assembly representing Baltimore City, the Mayor and City Council of Baltimore is authorized to

1 create a debt and to issue and sell its certificates of indebtedness (hereinafter called "bonds") as
2 evidence thereof, and proceeds not exceeding \$300,000 from the sale of such bonds to be used in
3 connection with the operations, functions, and activities of the Walters Art Museum as
4 authorized by said Resolution; and

5 **WHEREAS**, Funds are now needed for said purposes; now, therefore,

6 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE**, That the
7 Mayor and City Council of Baltimore, acting by and through the Board of Finance of said
8 municipality, be and it is hereby authorized and empowered to create a debt and to issue and sell
9 bonds of the Mayor and City Council of Baltimore from time to time, as may be needed or
10 required for the purposes hereinafter named and said bonds shall be sold by the Board of Finance
11 from time to time and at such times as shall be requisite, and proceeds not exceeding \$300,000
12 from the sale of such bonds shall be used for the purposes hereinafter named, provided that this
13 Ordinance shall not become effective unless it shall be approved by a majority of the votes of the
14 legal voters of Baltimore City cast at the time and place hereinafter designated by this Ordinance.

15 **SECTION 2. AND BE IT FURTHER ORDAINED**, That:

16 (a) The denomination or denominations of the bonds to be issued at any particular time
17 and the place or places for the payment of principal and interest thereof are to be determined by
18 the Board of Finance.

19 (b) The bonds authorized to be issued and sold under the provisions of this Ordinance
20 may be issued to mature on such dates and in such amounts as the Board of Finance may
21 determine; provided that the entire principal amount represented thereby shall be discharged not
22 more than 40 years from the date of issuance of the bonds.

23 (c) The bonds, when issued, shall bear interest at such rate or rates as may be determined
24 by the Board of Finance, which rate or rates may be fixed or variable or as determined by a
25 method approved by the Board of Finance, and such interest shall be payable at such time or
26 times as may be determined by the Board of Finance.

27 **SECTION 3. AND BE IT FURTHER ORDAINED**, That a majority of the Board of Finance of the
28 Mayor and City Council of Baltimore be, and they are hereby, authorized to pass a resolution or
29 resolutions, from time to time, to determine and set forth any or all of the following:

30 (a) The amount of debt to be incurred by the Mayor and City Council of Baltimore at any
31 particular time, and from time to time, under and pursuant to the provisions of this Ordinance;
32 the date or dates when any bonds representing said debt, or any part thereof, are to mature, and
33 the amount or amounts of said debt, or any part thereof, which shall mature upon the aforesaid
34 date or dates; and the date or dates in each year, during the entire period of time when any of said
35 bonds are outstanding, when interest on any of said bonds shall be payable;

36 (b) The form or forms of the bonds representing the debt, or any part thereof, authorized
37 to be issued under the provisions of this Ordinance at any particular time; and

38 (c) If the bonds are to be sold at public sale, the time, place, manner and medium of
39 advertisement of the readiness of the Board of Finance, acting for and on behalf of the Mayor and
40 City Council of Baltimore, to receive bids for the purchase of the bonds authorized to be issued

1 hereunder or any part thereof; the form, terms and conditions of such bids; the time, place and
2 manner of awarding bonds so bid for, including the right whenever any of the bonds authorized
3 by this Ordinance are offered for sale and sold at the same time as other bonds of the City, to
4 establish the conditions for bids and awards and to award all of the bonds on an all or none basis,
5 and the time, place, terms and manner of settlement for the bonds so bid for; provided, however,
6 that notwithstanding anything in this section, the Mayor and City Council of Baltimore, or the
7 Board of Finance, as the case may be, shall have the right to reject any or all bids therefor for any
8 reason.

9 SECTION 4. AND BE IT FURTHER ORDAINED, That:

10 (a) All premiums resulting from the sale of any of the bonds issued and sold pursuant to
11 the provisions of this Ordinance shall be applied as directed by the Board of Finance.

12 (b) The debt authorized by the provisions of this Ordinance, and the bonds issued and
13 sold pursuant thereto and their transfer, and the principal and interest payable thereon (including
14 any profit made in the sale thereof), shall be and remain exempt from any and all State, county
15 and municipal taxation in the State of Maryland.

16 (c) All bonds issued and sold pursuant to the provisions of this Ordinance may be sold at
17 public sale by the solicitation of competitive bids or at private (negotiated) sale without
18 advertisement or solicitation of competitive bids, for a price or prices which may be at, above or
19 below par value of the bonds, as determined by resolution of the Board of Finance of the Mayor
20 and City Council of Baltimore.

21 SECTION 5. AND BE IT FURTHER ORDAINED, That until all of the interest on and principal of
22 any bonds issued pursuant to the provisions of this Ordinance have been paid in full, the Mayor
23 and City Council of Baltimore shall levy and impose an annual tax on each \$100 of assessable
24 property in the City of Baltimore at a rate sufficient to produce revenue to pay all interest on and
25 principal of all bonds theretofore issued and outstanding or authorized to be issued and
26 outstanding, payable in the next succeeding year.

27 SECTION 6. AND BE IT FURTHER ORDAINED, That this Ordinance shall be submitted to the
28 legal voters of the City of Baltimore, for their approval or disapproval, at the General Election to
29 be held in Baltimore City, on Tuesday, the 6th day of November, 2012.

30 SECTION 7. AND BE IT FURTHER ORDAINED, That prior to the date of the election
31 hereinbefore mentioned, notice shall be given to the public of the amount of money which the
32 Mayor and City Council of Baltimore is authorized to borrow, and the general purposes for
33 which such borrowed funds may be expended, under the terms and provisions of this Ordinance,
34 and the time when the election hereinbefore mentioned is to be held; and such public notice shall
35 be given in such manner and by such means or through such media and at such time or times as
36 may be determined, from time to time, by a majority of the Board of Finance.

37 SECTION 8. AND BE IT FURTHER ORDAINED, That the actual cash proceeds derived from the
38 sale of the bonds authorized to be issued under the provisions of this Ordinance shall be used
39 exclusively for the following purposes, to wit:

40 (a) So much thereof as may be necessary for the cost of issuance, including the expense of
41 engraving, printing, advertising, attorneys' fees, and all other incidental expenses connected

1 therewith (which may include the proportion of the compensation of employees and general
2 administrative expenses of the Department of Finance reasonably allocated to the issuance of the
3 bonds); and

4 (b) The remainder of such proceeds shall be used for the Walters Art Museum, including
5 but not limited to, the acquisition by purchase, lease, condemnation or any other legal means, of
6 land or property, or any rights therein, in the City of Baltimore, and constructing and erecting on
7 said land or property, or on any land or property, new buildings, structures, and other auxiliary
8 facilities; and for the renovation, alteration, construction, reconstruction, installation,
9 improvement and repair of existing buildings, structures or facilities, to be or now being used for
10 or in connection with the operations, functions, and activities of the Walters Art Museum; and
11 for equipment for any and all facilities authorized to be constructed, renovated, altered or
12 improved by the provisions hereof; the payment of any and all costs and expenses incurred for or
13 in connection with doing any or all of the things herein mentioned, including but not limited to
14 the costs and expenses of securing administrative, appraisal, economic analysis, engineering,
15 planning, designing, architectural, surveying and other professional services; and for doing any
16 and all things necessary, proper or expedient in connection with or pertaining to any or all of the
17 matters or things hereinbefore mentioned.

18 **SECTION 9. AND BE IT FURTHER ORDAINED, That:**

19 (a) The Mayor and City Council of Baltimore, acting by and through the Board of Finance
20 thereof, is hereby authorized and empowered to issue its bonds for the purpose of refunding any
21 bonds authorized to be issued under the provisions of this Ordinance by payment at maturity or
22 the purchase or redemption of bonds in advance of maturity. The validity of any refunding bonds
23 shall in no way be dependent upon or related to the validity or invalidity of the bonds being
24 refunded. Such refunding bonds may be issued by the Mayor and City Council of Baltimore,
25 acting by and through the Board of Finance thereof, for the purpose of providing it with funds to
26 pay any of its outstanding bonds authorized to be issued under the provisions of this Ordinance at
27 maturity, to purchase in the open market any of its outstanding bonds authorized to be issued
28 under the provisions of this Ordinance prior to their maturity, to redeem prior to their maturity
29 any outstanding bonds which are, by their terms, redeemable, to pay interest on any outstanding
30 bonds prior to their payment at maturity or purchase or redemption in advance of maturity, or to
31 pay any redemption or purchase premium in connection with the refunding of any of its
32 outstanding bonds authorized to be issued under the provisions of this Ordinance.

33 (b) Any refunding bonds authorized to be issued and sold under the provisions of this
34 Ordinance may be issued for the public purpose of:

35 (1) Realizing savings to Baltimore City in the aggregate cost of debt service on either
36 a direct comparison or present value basis; or

37 (2) Debt restructuring that:

38 (i) In the aggregate effects such a reduction in the cost of debt service; or

39 (ii) Is determined by the Board of Finance of the Mayor and City Council of
40 Baltimore to be in the best interests of Baltimore City, to be consistent with Baltimore City's
41 long-term financial plan, and to realize a financial objective of Baltimore City including,

1 improving the relationship of debt service to a source of payment such as taxes, assessments, or
2 other charges.

3 (c) Any refunding bonds authorized to be issued and sold under the provisions of this
4 Ordinance may be issued in whatever principal amount shall be required to achieve the purpose
5 for the issuance of the refunding bonds, which amount may be in excess of the principal amount
6 of the bonds refunded or the maximum principal amount of bonds authorized to be issued under
7 Section 1 of this Ordinance.

8 (d) Any refunding bonds authorized to be issued and sold under the provisions of this
9 Ordinance may be issued to mature on such dates and in such amounts as the Board of Finance
10 may determine; provided that the entire principal amount represented by the refunding bonds
11 shall be discharged not more than 40 years from the date of issuance of the bonds being refunded.

12 (e) Any refunding bonds authorized to be issued and sold under the provisions of this
13 Ordinance may be sold at public sale by the solicitation of competitive bids or at private
14 (negotiated) sale without advertisement or solicitation of competitive bids, for a price or prices
15 which may be at, above or below the par value of the refunding bonds, as determined by
16 resolution of the Board of Finance of the Mayor and City Council of Baltimore.

17 (f) Any refunding bonds authorized to be issued and sold under the provisions of this
18 Ordinance shall bear interest at such rate or rates as may be determined by the Board of Finance
19 of the Mayor and City Council of Baltimore, which rate or rates may be fixed or variable or as
20 determined by a method approved by the Board of Finance, and such interest shall be payable at
21 such time or times as may be determined by the Board of Finance.

22 (g) The proceeds of the sale of any refunding bonds authorized to be issued and sold
23 under the provisions of this Ordinance, after the payment of issuance costs relating thereto, shall
24 be set aside by the Mayor and City Council of Baltimore as a separate trust fund to be used solely
25 for the purposes stated in this Section 9.

26 (h) Except as otherwise provided in this Section 9, the powers granted in, the limitations
27 and obligations imposed by, and the procedures specified in this Ordinance with respect to the
28 issuance of bonds shall be applicable to the issuance of refunding bonds.

29 (i) Any refunding bonds authorized to be issued and sold under the provisions of this
30 Ordinance shall not be subject to any debt policy limitation that may from time to time be
31 established by the Mayor and City Council of Baltimore.

32 **SECTION 10. AND BE IT FURTHER ORDAINED,** That the expenditure of the proceeds derived
33 from the sale of the bonds authorized to be issued under the provisions of this Ordinance shall be
34 in accordance with the provisions of the Charter of the Mayor and City Council of Baltimore, and
35 by the municipal agency designated in the annual Ordinance of Estimates of the Mayor and City
36 Council of Baltimore.
