BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That \$2,500,000 shall be made available to the Department of General Services – Service 726 (Administration – General Services) as a Supplementary General Fund Operating Appropriation for Fiscal Year 2020, to provide funding for unanticipated expenditures because of the COVID-19 pandemic. The source of revenue for this appropriation is funds from the Budget Stabilization Reserve in excess of the amount from this source that was relied on by the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2020.
