### AN ORDINANCE CONCERNING

2	FOR the purpose of requiring the minutes of the Board of Municipal and Zoning Appeals to			
3	include, on each question, the Board's findings of fact and its decision; requiring notice of			
4	public hearings by the Board to be posted on the subject property; requiring the Board to			
5	decide a matter within 30 75 days of the hearing; requiring the Board to schedule certain			
6	public hearings to start after a certain time; requiring all voting sessions to be open to the			
7	public; precluding Board members from participating at a hearing unless they are physically			
8	present; precluding Board members from voting on a matter unless they were physically			
9 10	present at the hearing on the matter and are physically present at the voting session; and generally relating to hearings by the Board of Municipal and Zoning Appeals.

17 18 19	(4) REQUIRE THE APPLICANT, APPELLANT, OR OTHER PERSON INITIATING THE HEARING TO POST THE SUBJECT PROPERTY, AT LEAST 45 21 DAYS BEFORE THE HEARING, WITH A NOTICE OF THE TIME, PLACE, AND PURPOSE OF THE HEARING; and
20	(5) [(4)] decide the matter within [a reasonable time after] 30 75 DAYS OF the hearing.

22	(1) All hearings of the Board must be open to the public.
23 24 25	(2) IN ANY AT LEAST ONCE IN EVERY 2 CALENDAR MONTH MONTHS, DURING WHICH THE BOARD CONDUCTS ONE OR MORE PUBLIC HEARINGS, AT LEAST ONE 1 SESSION OF HEARINGS MUST BE SCHEDULED TO BEGIN AFTER 5 P.M.
26	(E) MEMBERS' PRESENCE REQUIRED TO PARTICIPATE.
27	A BOARD MEMBER MUST BE PHYSICALLY PRESENT TO PARTICIPATE AT A HEARING.

2	(a) VOTING SESSIONS TO BE PUBLIC.
3	ALL VOTING SESSIONS OF THE BOARD MUST BE OPEN TO THE PUBLIC.
4	(B) NUMBER OF VOTES.
5	The number of votes specified in State Code Article 66B is required for the Board to:
6 7	(1) reverse any order, requirement, decision, or determination of the Zoning Administrator; or
8 9	(2) decide in favor of the applicant on any matter on which it is required to pass under this article.
10	(C) Presence required to vote.
11	A BOARD MEMBER MAY NOT VOTE ON A MATTER UNLESS THE BOARD MEMBER:
12	(1) WAS PHYSICALLY PRESENT AT THE PUBLIC HEARING ON THE MATTER: AND
13	(2) IS PHYSICALLY PRESENT AT THE VOTING SESSION.
14 15 16	<b>SECTION 2. AND BE IT FURTHER ORDAINED</b> , That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.
17 18	<b>SECTION 3. AND BE IT FURTHER ORDAINED</b> , That this Ordinance takes effect on the 30th day after the date it is enacted.
