1 AN ORDINANCE concerning

2 **Supplementary Motor Vehicle Fund Operating Appropriation –**
3 **Department of Transportation – \$3,700,000**

4 FOR the purpose of providing a Supplementary Motor Vehicle Fund Operating Appropriation in
5 the amount of \$3,700,000 to the Department of Transportation – Program 501 (Highway
6 Maintenance), to provide funding for additional operating expenses; and providing for a
7 special effective date.

13 **Recitals**

14 The revenue appropriated by this Ordinance represents funds from the Fiscal 2007 Fund
15 Balance in excess of the revenue relied on by the Board of Estimates in determining the tax levy
16 required to balance the budget for Fiscal Year 2008.

17 This additional revenue could not have been reasonably anticipated when the Ordinance of
18 Estimates for Fiscal Year 2008 was formulated.

19 This appropriation is made necessary by a material change in circumstances since the
20 Ordinance of Estimates for Fiscal Year 2008 was formulated or is for a new program that could
21 not have been reasonably anticipated when that Ordinance of Estimates was formulated.

22 On May 14, 2008, the Board of Estimates recommended this appropriation to the City
23 Council.

24 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That**
25 **\$3,700,000 shall be made available to the Department of Transportation – Program 501**
26 **(Highway Maintenance) as a Supplementary Motor Vehicle Fund Operating Appropriation for**
27 **Fiscal Year 2008, to provide funding for additional operating expenses. The source of revenue**

1 for this appropriation is funds from the Fiscal 2007 Fund Balance in excess of the amount from
2 this source that was relied on by the Board of Estimates in determining the tax levy required to
3 balance the budget for Fiscal Year 2008.

4 **SECTION 2. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the date it
5 is enacted.
