**A COUNCIL RESOLUTION CONCERNING**

**Baltimore Education Coalition - Full Funding for City Schools**

2 FOR the purpose of supporting the Baltimore Education Coalition’s Education Funding Rally in  
3 Annapolis on February 28, 2011 and urging the Baltimore City Senate and House  
4 Delegations to the Maryland General Assembly and the Governor of Maryland to restore the  
5 proposed cuts for funding to Baltimore City Schools.

6 **WHEREAS**, the Governor’s budget for 2012 will cut more than \$15 million in funding for  
7 Baltimore City Schools, causing schools to lose teachers, support staff, and after school  
8 programs and increasing the number of students in each classroom; and

9 **WHEREAS**, the Governor must change the “Thornton” education law to make these cuts and,  
10 further, proposes to make them permanent, which will mean permanent cuts to City Schools in  
11 future years; and

12 **WHEREAS**, the “Thornton” law was enacted to ensure that students receive adequate funding  
13 for a “thorough and efficient” education as guaranteed by the state Constitution, resulting in  
14 great progress in Baltimore City Schools in recent years, including the facts that our students  
15 have achieved higher proficiency on math and reading tests each year since the “Thornton”  
16 education funding law was adopted in 2002, school enrollment is growing, more students are  
17 graduating, and the rate of students who drop out has decreased by nearly 60% since 2007; and

18 **Whereas**, cuts to school funding undermine this progress and betray our commitment to  
19 providing a quality education for all of Baltimore’s children, meaning that the burden of a state  
20 budget deficit will be shifted to our most vulnerable population – our children; and

21 **WHEREAS**, with leadership from the Baltimore Education Coalition, school communities  
22 across the city are calling on the Governor to restore full funding in the budget for City Schools;  
23 and

24 **WHEREAS**, parents, families, and community members are exhorting the Baltimore City  
25 Delegation to the General Assembly to oppose any cuts to school funding for Baltimore; and

26 **WHEREAS**, on February 28, 2011, the Baltimore Education Coalition will hold an Education  
27 Funding Rally in Annapolis to ask the Governor and our state legislators to restore our \$15  
28 million for City School students; and

29 **WHEREAS**, citizens from across Baltimore City will join to make their voices heard, and  
30 stand together in steadfast support of our children and our schools.
