1 AN ORDINANCE concerning

2 **Supplementary General Fund Operating Appropriation –**
3 **MR-Miscellaneous General Expenses – \$301,696**

4 FOR the purpose of providing a Supplementary General Fund Operating Appropriation in the
5 amount of \$301,696 to the MR-Miscellaneous General Expenses – Program 122
6 (Miscellaneous General Expenses), to provide funding for After School Programs; and
7 providing for a special effective date.

13 **Recitals**

14 The revenue appropriated by this Ordinance represents funds from the Fiscal 2007 Fund
15 Balance in excess of the revenue relied on by the Board of Estimates in determining the tax levy
16 required to balance the budget for Fiscal Year 2008.

17 This additional revenue could not have been reasonably anticipated when the Ordinance of
18 Estimates for Fiscal Year 2008 was formulated.

19 This appropriation is made necessary by a material change in circumstances since the
20 Ordinance of Estimates for Fiscal Year 2008 was formulated or is for a new program that could
21 not have been reasonably anticipated when that Ordinance of Estimates was formulated.

22 On September 26, 2007, the Board of Estimates recommended this appropriation to the City
23 Council.

24 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That
25 \$301,696 shall be made available to the MR-Miscellaneous General Expenses – Program 122
26 (Miscellaneous General Expenses) as a Supplementary General Fund Operating Appropriation
27 for Fiscal Year 2008, to provide funding for After School Programs. The source of revenue for
28 this appropriation is funds from the Fiscal 2007 Fund Balance in excess of the amount from this

1 source that was relied on by the Board of Estimates in determining the tax levy required to
