A BILL ENTITLED

1 AN ORDINANCE concerning

2 **Supplementary General Fund Capital Appropriation –**  
3 **Department of Housing and Community Development – \$1,000,000**

4 FOR the purpose of providing a Supplementary General Fund Capital Appropriation in the  
5 amount of \$1,000,000 to the Department of Housing and Community Development  
6 (Account #9910-588-054), to provide funding for the Community Restoration Program; and  
7 providing for a special effective date.

9 Article VI - Board of Estimates

13 **Recitals**

14 The revenue appropriated by this Ordinance represents funds from the Fiscal 2007 Fund  
15 Balance in excess of the revenue relied on by the Board of Estimates in determining the tax levy  
16 required to balance the budget for Fiscal Year 2008.

17 This additional revenue could not have been reasonably anticipated when the Ordinance of  
18 Estimates for Fiscal Year 2008 was formulated.

19 This appropriation is made necessary by a material change in circumstances since the  
20 Ordinance of Estimates for Fiscal Year 2008 was formulated or is for a new program that could  
21 not have been reasonably anticipated when that Ordinance of Estimates was formulated.

22 On June 27, 2007, the Board of Estimates recommended this appropriation to the City  
23 Council.

24 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That**  
25 **\$1,000,000 shall be made available to the Department of Housing and Community Development**  
26 **(Account #9910-588-054) as a Supplementary General Fund Capital Appropriation for Fiscal**  
27 **Year 2008, to provide funding for the Community Restoration Program. The source of revenue**

EXPLANATION: CAPITALS indicate matter added to existing law.  
[Brackets] indicate matter deleted from existing law.

1 for this appropriation is funds from the Fiscal 2007 Fund Balance in excess of the amount from  
2 this source that was relied on by the Board of Estimates in determining the tax levy required to  
3 balance the budget for Fiscal Year 2008.

4 **SECTION 2. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the date it  
5 is enacted.
