1	Repeal of Ordinance 06-222 – Planned Unit Development – 1100 Wicomico Street
2	FOR the purpose of repealing Ordinance 06-222, which designated certain property located at
3	1100 Wicomico Street an Industrial Planned Unit Development; and providing for a special
4	effective date.
5	By repealing
6	Ordinance 06-222
7	Recitals
8	By Ordinance 06-222, the Mayor and City Council approved: (i) the application of GFI
9	Raleigh, LLC to have that property located at 1100 Wicomico Street, consisting of approximately
10	2.02 acres, more or less, and improved by an 8-story, 400,000 square foot building and structured
11	parking facility designated as an Industrial Planned Unit Development; and (ii) the related
12	Development Plan submitted by the applicant.
13	TTV Wicomico, LLC wishes to repeal Ordinance 06-222, as previously approved by the
14	Mayor and City Council to develop the property in a manner that aligns with the underlying
15	IMU-1 Zoning District.
16	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That
17	Ordinance 06-222 is repealed, and the authority conferred in that Ordinance to designate certain
18	property located at 1100 Wicomico Street an Industrial Planned Unit Development is rescinded.
19	SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it is
20	enacted.
