AN ORDINANCE CONCERNING

Valet Parking

1
2 FOR the purpose of regulating the provision of valet parking services; requiring valet parking
3 operators to be licensed; requiring permits for valet parking zones; establishing certain
4 standards of operation; defining certain terms; imposing certain penalties; providing for
5 certain appeals and reviews; correcting, clarifying, and conforming related provisions
6 governing passenger loading zones and freight loading zones; designating passenger loading
7 zones, freight loading zones, and valet parking zones as impoundment areas; clarifying
8 responsibility for collecting applicable parking taxes; providing for a special effective date;
9 and generally relating to the licensing and regulation of valet parking services.

21 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That the
22 Laws of Baltimore City read as follows:

24 **Article 31. Transit and Traffic**

25 **Subtitle 1. Definitions; General Provisions**

26 **§ 1-1. Definitions — A to L.**

27 [(m) *Freight {curb} loading zone.*

28 “Freight {curb} loading zone” means a space adjacent to a curb reserved for the exclusive
29 use of commercial vehicles during the expeditious taking on or discharging of property.]

30 **§ 1-2. Definitions — M to R.**

31 [(e) *Passenger {curb} loading zone.*

32 “Passenger {curb} loading zone” means a space adjacent to a curb reserved for the
33 exclusive use of vehicles taking on or discharging passengers or passengers’ baggage
34 transported upon the same vehicle.]

Subtitle 6. Parking, Standing, and Stopping Regulations

Part 2. Places Prohibited

§ 6-16. Passenger and freight curb loading zones.

(A) *DEFINITIONS.*

(1) *IN GENERAL.*

IN THIS SECTION, THE FOLLOWING TERMS HAVE THE MEANINGS INDICATED.

(2) *FREIGHT LOADING ZONE.*

“FREIGHT LOADING ZONE” MEANS A SPACE ADJACENT TO A CURB THAT, DURING SPECIFIED TIMES, IS RESERVED EXCLUSIVELY FOR THE USE OF COMMERCIAL VEHICLES DURING THE EXPEDITIOUS LOADING OR UNLOADING OF PROPERTY.

(3) *PASSENGER LOADING ZONE.*

(I) “PASSENGER LOADING ZONE” MEANS A SPACE ADJACENT TO A CURB THAT, DURING SPECIFIED TIMES, IS RESERVED EXCLUSIVELY FOR THE USE OF VEHICLES THAT ARE LOADING OR UNLOADING PASSENGERS AND THEIR BAGGAGE.

(II) “PASSENGER LOADING ZONE” DOES NOT INCLUDE A VALET PARKING ZONE ESTABLISHED UNDER TITLE 14 {“VALET PARKING”} OF THIS ARTICLE.

(B) [(a) *Location*] *ESTABLISHMENT OF ZONES*; signs.

(1) The Director of ~~Public Works~~ TRANSPORTATION[(1) is hereby authorized to] MAY determine the location of AND OPERATIONAL HOURS FOR passenger LOADING ZONES and freight [curb] loading zones[; and].

(2) THE DIRECTOR shall place and maintain AT EACH PASSENGER LOADING ZONE AND FREIGHT LOADING ZONE appropriate signs THAT:

(i) [indicating] INDICATE the location of [such zones] THE ZONE; and

(ii) [stating] STATE the OPERATIONAL hours during which the [following provisions] RESTRICTIONS of this section [are applicable] APPLY.

(C) [(b)] *Freight LOADING zones.*

(1) No person [shall be permitted to] MAY park a vehicle in [any place marked as] a freight [curb] loading zone FOR ANY PURPOSE OR PERIOD OF TIME during ITS OPERATIONAL hours [when the provisions applicable to such a zone are in effect].

(2) No [vehicle shall be permitted to] PERSON MAY stop A VEHICLE in a freight [curb] loading zone FOR ANY PURPOSE OR PERIOD OF TIME DURING ITS OPERATIONAL HOURS unless:

1 (I) THE VEHICLE IS A COMMERCIAL VEHICLE actually in the process of
2 expeditiously loading or unloading [materials] PROPERTY[.]; OR

3 (II) [(3) Nothing in this section shall prohibit] THE VEHICLE IS a passenger vehicle
4 [from] stopping temporarily [at a place marked as a freight curb loading zone]
5 for the purpose of and while actually engaged in EXPEDITIOUSLY loading or
6 unloading passengers, [when such] AS LONG AS ITS stopping does not interfere
7 with any [motor] COMMERCIAL vehicle THAT IS [used for transportation of
8 materials which is] waiting to enter or about to enter [such] THAT zone.

9 (D) [(c)] *Passenger LOADING zones.*

10 (1) NO PERSON MAY PARK A VEHICLE IN A PASSENGER LOADING ZONE FOR ANY PURPOSE
11 OR PERIOD OF TIME DURING ITS OPERATIONAL HOURS.

12 (2) No person [shall] MAY stop a vehicle in [the] A PASSENGER LOADING zone for any
13 purpose or period of time DURING ITS OPERATIONAL HOURS [other than for] UNLESS
14 THE VEHICLE IS A PASSENGER VEHICLE STOPPING TEMPORARILY FOR THE PURPOSE OF
15 AND WHILE ACTUALLY ENGAGED IN [the expeditious] EXPEDITIOUSLY loading or
16 unloading of passengers AND THEIR BAGGAGE [at any place marked as a passenger
17 curb loading zone during hours when the regulations applicable to such curb loading
18 zones are effective, and then, only for a period not to exceed 10 minutes].

19 **§ 6-17. VALET PARKING ZONES.**

20 (A) *“VALET PARKING ZONE” DEFINED.*

21 IN THIS SECTION, “VALET PARKING ZONE” HAS THE MEANING STATED IN § 14-1 OF THIS
22 ARTICLE.

23 (B) *PARKING PROHIBITED.*

24 NO PERSON MAY PARK A VEHICLE IN A VALET PARKING ZONE FOR ANY PURPOSE OR PERIOD
25 OF TIME DURING ITS OPERATIONAL HOURS UNLESS THE PERSON:

26 (1) IS IN THE PROCESS OF SEEKING VALET PARKING SERVICES THEN BEING PROVIDED
27 THERE; AND

28 (2) HAS BEEN INSTRUCTED BY THE VALET PARKING ATTENDANT TO PARK THERE.

29 (C) *STOPPING PROHIBITED.*

30 NO PERSON MAY STOP A VEHICLE IN A VALET PARKING ZONE FOR ANY PURPOSE OR PERIOD
31 OF TIME DURING ITS OPERATIONAL HOURS UNLESS:

32 (1) THE PERSON IS IN THE PROCESS OF SEEKING THE VALET PARKING SERVICES BEING
33 OFFERED THERE; OR

34 (2) THE VEHICLE IS A PASSENGER VEHICLE STOPPING TEMPORARILY FOR THE PURPOSE
35 OF AND WHILE ACTUALLY ENGAGED IN EXPEDITIOUSLY LOADING OR UNLOADING

1 PASSENGERS, AS LONG AS ITS STOPPING DOES NOT INTERFERE WITH ANY OTHER
2 VEHICLE THAT IS WAITING TO ENTER OR ABOUT TO ENTER THE ZONE FOR VALET
3 PARKING SERVICES.

4 **SUBTITLE 14. VALET PARKING**

5 ***PART I. DEFINITIONS; GENERAL PROVISIONS***

6 **§ 14-1. DEFINITIONS.**

7 (A) *IN GENERAL.*

8 IN THIS SUBTITLE, THE FOLLOWING TERMS HAVE THE MEANINGS INDICATED.

9 (B) *ATTENDANT.*

10 “ATTENDANT” MEANS ANY INDIVIDUAL WHO DIRECTS, DRIVES, PARKS, OR OTHERWISE
11 ASSUMES CONTROL OF A VEHICLE AS PART OF A VALET PARKING SERVICE.

12 (C) *AUTHORITY.*

13 “AUTHORITY” MEANS THE BALTIMORE CITY PARKING AUTHORITY.

14 (D) *BOARD OF DIRECTORS.*

15 “BOARD OF DIRECTORS” MEANS THE AUTHORITY’S BOARD OF DIRECTORS.

16 (E) *CONTRACT-OPERATOR.*

17 “CONTRACT-OPERATOR” MEANS AN OPERATOR THAT PROVIDES VALET PARKING SERVICES
18 UNDER CONTRACT WITH A HOST.

19 (F) *DIRECTOR OF TRANSPORTATION.*

20 “DIRECTOR OF TRANSPORTATION” MEANS THE DIRECTOR OF THE DEPARTMENT OF
21 TRANSPORTATION OR THE DIRECTOR’S DESIGNEE.

22 (G) *EXECUTIVE DIRECTOR.*

23 “EXECUTIVE DIRECTOR” MEANS THE EXECUTIVE DIRECTOR OF THE AUTHORITY OR THE
24 EXECUTIVE DIRECTOR’S DESIGNEE.

25 (H) *HOST.*

26 “HOST” MEANS ANY BUSINESS ESTABLISHMENT OR OTHER PERSON THAT OFFERS VALET
27 PARKING SERVICES TO ITS PATRONS, WHETHER:

28 (1) DIRECTLY THROUGH ITS OWN EMPLOYEES OR AGENTS; OR

29 (2) INDIRECTLY BY CONTRACT WITH ANOTHER PERSON.

1 (I) *HOST-OPERATOR*.

2 “HOST-OPERATOR” MEANS A HOST THAT PROVIDES VALET PARKING SERVICES DIRECTLY
3 THROUGH ITS OWN EMPLOYEES OR AGENTS.

4 (J) *INCLUDES; INCLUDING*.

5 “INCLUDES” OR “INCLUDING” MEANS BY WAY OF ILLUSTRATION AND NOT BY WAY OF
6 LIMITATION.

7 (K) *OPERATOR*.

8 (1) “OPERATOR” MEANS ANY PERSON THAT, THROUGH ITS EMPLOYEES OR AGENTS,
9 PROVIDES OR OFFERS TO PROVIDE VALET PARKING SERVICES, WHETHER AS A
10 CONTRACT-OPERATOR OR A HOST OPERATOR.

11 (2) “OPERATOR” INCLUDES ANY HOST THAT PROVIDES OR OFFERS TO PROVIDE VALET
12 PARKING SERVICES THROUGH ITS OWN EMPLOYEES OR AGENTS.

13 (L) *PERSON*.

14 (1) *IN GENERAL*.

15 “PERSON” MEANS:

16 (I) AN INDIVIDUAL;

17 (II) A PARTNERSHIP, FIRM, ASSOCIATION, CORPORATION, OR OTHER ENTITY OF ANY
18 KIND; OR

19 (III) A RECEIVER, TRUSTEE, GUARDIAN, PERSONAL REPRESENTATIVE, FIDUCIARY,
20 OR REPRESENTATIVE OF ANY KIND.

21 (2) *EXCLUSIONS*.

22 “PERSON” DOES NOT INCLUDE, UNLESS OTHERWISE EXPRESSLY PROVIDED, A
23 GOVERNMENTAL ENTITY OR AN INSTRUMENTALITY OR UNIT OF A GOVERNMENTAL
24 ENTITY.

25 (M) *PRINCIPAL*.

26 “PRINCIPAL”, AS USED WITH RESPECT TO AN OPERATOR OR HOST, MEANS:

27 (1) A SOLE PROPRIETOR OF THE OPERATOR OR HOST;

28 (2) A PARTNER, OFFICER, OR DIRECTOR OF THE OPERATOR OR HOST; OR

29 (3) ANY STOCKHOLDER OF THE OPERATOR OR HOST WHO:

1 (I) OWNS MORE THAN 25% OF THE VOTING STOCK OF THE OPERATOR OR HOST;
2 OR

3 (II) NOTWITHSTANDING THE PERCENTAGE OF SHARES OWNED, HAS THE POWER
4 TO DIRECT OR CONTROL THE DIRECTION OF THE OPERATOR'S OR HOST'S
5 MANAGEMENT OR POLICIES.

6 (N) *VALET PARKING SERVICE*.

7 (1) "VALET PARKING SERVICE" MEANS, EXCEPT AS SPECIFIED IN PARAGRAPH (3) OF THIS
8 SUBSECTION, ANY OF THE FOLLOWING ACTS PERFORMED FOR THE BENEFIT OF A
9 VEHICLE'S DRIVER:

10 (I) MOVING A VEHICLE FROM ONE LOCATION TO ANOTHER LOCATION FOR
11 PARKING; OR

12 (II) RETURNING A VEHICLE FROM ITS PARKED LOCATION TO ANOTHER LOCATION
13 FOR PICK-UP.

14 (2) "VALET PARKING SERVICE" INCLUDES ANY ACT DESCRIBED IN PARAGRAPH (1) OF THIS
15 SUBSECTION, WHETHER:

16 (I) A FEE IS CHARGED FOR THE SERVICE OR NOT; OR

17 (II) THE SERVICE IS PROVIDED BY THE HOST DIRECTLY OR BY ANOTHER PERSON
18 UNDER CONTRACT WITH THE HOST.

19 (3) "VALET PARKING SERVICE" DOES NOT INCLUDE ATTENDANT PARKING AT AN OFF-
20 STREET PARKING FACILITY.

21 (O) *VALET PARKING ZONE*.

22 "VALET PARKING ZONE" MEANS A SPACE ADJACENT TO A CURB THAT, DURING SPECIFIED
23 TIMES, IS RESERVED EXCLUSIVELY FOR VALET PARKING SERVICES.

24 **§ 14-2. MANDATORY, PROHIBITORY, AND PERMISSIVE TERMS.**

25 (A) *MANDATORY TERMS*.

26 "MUST" AND "SHALL" ARE EACH MANDATORY TERMS USED TO EXPRESS A REQUIREMENT
27 OR TO IMPOSE A DUTY.

28 (B) *PROHIBITORY TERMS*.

29 "MUST NOT" AND "MAY NOT" ARE EACH MANDATORY NEGATIVE TERMS USED TO
30 ESTABLISH A PROHIBITION.

1 (C) *PERMISSIVE TERMS.*

2 "MAY" IS PERMISSIVE.

3 **§ 14-3. RULES AND REGULATIONS.**

4 (A) *ADOPTION.*

5 (1) THE DIRECTOR OF TRANSPORTATION, IN CONSULTATION WITH THE AUTHORITY, MUST
6 ADOPT RULES AND REGULATIONS TO CARRY OUT THIS SUBTITLE.

7 (2) THE DIRECTOR OF TRANSPORTATION MUST OBTAIN PRIOR APPROVAL OF THE BOARD
8 OF ESTIMATES FOR ANY RULE OR REGULATION THAT SETS AN APPLICATION, LICENSE,
9 PERMIT, OR OTHER FEE TO BE IMPOSED UNDER THIS SUBTITLE.

10 (B) *FILING WITH LEGISLATIVE REFERENCE.*

11 A COPY OF ALL RULES AND REGULATIONS MUST BE FILED WITH THE DEPARTMENT OF
12 LEGISLATIVE REFERENCE BEFORE THEY TAKE EFFECT.

13 **§ 14-4. {RESERVED}**

14 **§ 14-5. EXEMPTIONS FOR CERTAIN TEMPORARY OPERATIONS.**

15 (A) *FULL EXEMPTION.*

16 THIS SUBTITLE DOES NOT APPLY TO A TEMPORARY VALET PARKING SERVICE IF:

17 (1) NO PROFESSIONAL OPERATOR IS BEING USED FOR THE SERVICE;

18 (2) NO FEE IS CHARGED TO DRIVERS OR PASSENGERS USING THE SERVICE;

19 (3) THE SERVICE IS BEING PROVIDED:

20 (I) AT A PRIVATE RESIDENCE; OR

21 (II) FOR A PUBLIC ENTITY; AND

22 (4) THE SERVICE IS BEING PROVIDED BY THE HOST FOR NO MORE THAN 3 DAYS IN ANY
23 12-MONTH PERIOD.

24 (B) *PARTIAL EXEMPTION.*

25 IF A PROFESSIONAL OPERATOR IS BEING USED FOR THE SERVICE, BUT ALL OF THE OTHER
26 CONDITIONS SPECIFIED IN SUBSECTION (A) OF THIS SECTION ARE MET:

27 (1) A PARKING ZONE PERMIT UNDER PART III OF THIS SUBTITLE IS NOT REQUIRED FOR
28 THE SERVICE;

1 (2) THE OPERATOR MUST BE LICENSED UNDER PART II OF THIS SUBTITLE AND, EXCEPT
2 AS PROVIDED IN ITEM (3) OF THIS SUBSECTION, MUST COMPLY WITH ALL OTHER
3 APPLICABLE REQUIREMENTS OF THIS SUBTITLE; AND

4 (3) WITH THE APPROVAL OF THE DIRECTOR OF TRANSPORTATION, THE EXECUTIVE
5 DIRECTOR MAY ALLOW THE OPERATOR TO USE PUBLIC RIGHTS-OF-WAY FOR
6 PARKING, SUBJECT TO THE ISSUANCE OF ALL PERMITS OTHERWISE REQUIRED FOR
7 THE USE OF PUBLIC RIGHTS-OF-WAY.

8 **§ 14-6. {RESERVED}**

9 ***PART II. VALET OPERATOR'S LICENSE***

10 **§ 14-7. LICENSE REQUIRED.**

11 NO OPERATOR MAY PROVIDE OR OFFER TO PROVIDE ANY VALET PARKING SERVICE WITHOUT
12 FIRST HAVING OBTAINED AN OPERATOR'S LICENSE FROM THE AUTHORITY.

13 **§ 14-8. QUALIFICATIONS FOR LICENSE.**

14 (A) *IN GENERAL.*

15 TO QUALIFY FOR AN OPERATOR'S LICENSE, AN APPLICANT MUST MEET THE REQUIREMENTS
16 OF THIS SECTION.

17 (B) *PRIOR INFRACTIONS.*

18 NEITHER THE APPLICANT NOR ANY OF THE APPLICANT'S PRINCIPALS, EMPLOYEES,
19 ATTENDANTS OR OTHER AGENTS MAY HAVE COMMITTED AN ACT OR OMISSION WITHIN THE
20 PRECEDING 12 MONTHS THAT, UNDER § 14-41 OF THIS SUBTITLE, IS CAUSE FOR THE
21 DENIAL, SUSPENSION, OR REVOCATION OF AN OPERATOR'S LICENSE.

22 (C) *LIABILITY INSURANCE.*

23 (1) THE APPLICANT MUST HAVE AND MAINTAIN LIABILITY INSURANCE COVERAGE THAT
24 COVERS, AS INSURED PARTIES:

25 (I) THE APPLICANT;

26 (II) ALL HOSTS FOR WHICH THE OPERATOR IS OR MAY BECOME UNDER CONTRACT
27 DURING THE TERM OF THE LICENSE; AND

28 (III) THE MAYOR AND CITY COUNCIL OF BALTIMORE.

29 (2) THE COVERAGE PROVIDED MUST BE OF THE TYPE AND FOR THE AMOUNT THAT THE
30 CITY'S OFFICE OF RISK MANAGEMENT REASONABLY PRESCRIBES.

§ 14-9. APPLICATIONS.

(A) *FORM.*

AN APPLICATION FOR AN OPERATOR'S LICENSE MUST BE SUBMITTED IN THE FORM REQUIRED BY THE RULES AND REGULATIONS ADOPTED UNDER THIS SUBTITLE.

(B) *APPLICATION FEE.*

(1) THE APPLICATION MUST BE ACCOMPANIED BY A NON-REFUNDABLE APPLICATION FEE TO COVER THE COST OF INVESTIGATING AND PROCESSING THE APPLICATION.

(2) THE AMOUNT OF THE FEE IS AS SET FORTH IN THE RULES AND REGULATIONS ADOPTED UNDER THIS SUBTITLE.

(C) *CONTENTS.*

THE APPLICATION MUST CONTAIN:

(1) THE APPLICANT'S FULL LEGAL NAME AND ANY TRADE NAME(S) UNDER WHICH IT OPERATES;

(2) THE STREET ADDRESS, TELEPHONE NUMBER, AND EMAIL ADDRESS OF THE APPLICANT'S PRINCIPAL PLACE OF BUSINESS;

(3) THE STREET ADDRESS, TELEPHONE NUMBER, AND EMAIL ADDRESS OF ANY OTHER OF APPLICANT'S PLACES OF BUSINESS IN THE CITY;

(4) THE NAMES, STREET ADDRESSES, TELEPHONE NUMBERS, AND EMAIL ADDRESSES OF THE APPLICANT'S PRINCIPALS;

(5) PROOF OF INSURANCE IN THE FORM AND AMOUNT REQUIRED UNDER § 14-8(C) {"QUALIFICATIONS: LIABILITY INSURANCE"} OF THIS SUBTITLE;

(6) A STATEMENT AS TO WHETHER THE APPLICANT PROPOSES TO PROVIDE VALET PARKING SERVICES AS A HOST-OPERATOR OR AS A CONTRACT-OPERATOR;

(7) A LISTING OF ALL VALET PARKING LICENSES OR VALET PARKING PERMITS ISSUED TO THE APPLICANT OR TO ANY PRINCIPAL OF THE APPLICANT WITHIN THE PRECEDING 5 YEARS, WHETHER BY THE CITY OR ANY OTHER JURISDICTION;

(8) A LIST OF ALL HOSTS IN THE CITY OR ANY OTHER JURISDICTION THAT HAVE USED THE APPLICANT'S SERVICES WITHIN THE PRECEDING 2 YEARS;

(9) CERTIFICATION THAT NEITHER THE APPLICANT NOR ANY OF THE APPLICANT'S PRINCIPALS, EMPLOYEES, ATTENDANTS OR OTHER AGENTS HAVE COMMITTED AN ACT OR OMISSION WITHIN THE PRECEDING 12 MONTHS THAT, UNDER § 14-41 OF THIS SUBTITLE, IS CAUSE FOR THE DENIAL, SUSPENSION, OR REVOCATION OF AN OPERATOR'S LICENSE;

1 (10) CERTIFICATION THAT EACH ATTENDANT EMPLOYED BY THE APPLICANT:

2 (I) POSSESSES A VALID DRIVER’S LICENSE; AND

3 (II) IS 18 YEARS OLD OR OLDER; AND

4 (11) ANY OTHER INFORMATION REQUIRED BY THE RULES AND REGULATIONS ADOPTED
5 UNDER THIS SUBTITLE.

6 (D) *SIGNATURE AND VERIFICATION.*

7 THE APPLICATION MUST BE SIGNED, UNDER OATH OR AFFIRMATION, SUBJECT TO THE
