12	The revenue appropriated by this Ordinance represents funds from the Assigned General
13	Fund Balance (\$6,000,000), the Transfer Tax (\$10,000,000), and the Recordation Tax
14	(\$10,000,000), in excess of the revenue relied on by the Board of Estimates in determining the
15	tax levy required to balance the budget for Fiscal Year 2016.
16	This additional revenue could not have been reasonably anticipated when the Ordinance of
17	Estimates for Fiscal Year 2016 was formulated.
18	This appropriation is made necessary by a material change in circumstances since the
19	Ordinance of Estimates for Fiscal Year 2016 was formulated or is for a new program that could
20	not have been reasonably anticipated when that Ordinance of Estimates was formulated.
21	On June 1, 2016, the Board of Estimates recommended this appropriation to the City
22	Council.
23	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That
24	\$26,000,000 shall be made available to the Police Department – Service 622 (Police Patrol) as a
