**AN ORDINANCE CONCERNING**

**Urban Renewal – Middle East –  
Amendment 15**

3 FOR the purpose of amending the Urban Renewal Plan for Middle East to extend the life of the  
4 Plan, and to remove certain properties from the list in Appendices A, C, and D; waiving  
5 certain content and procedural requirements; making the provisions of this Ordinance  
6 severable; providing for the application of this Ordinance in conjunction with certain other  
7 ordinances; and providing for a special effective date.

13 **Recitals**

14 The Urban Renewal Plan for Middle East was originally approved by the Mayor and City  
15 Council of Baltimore by Ordinance 79-1202 and last amended by Ordinance 21-029.

16 An amendment to the Urban Renewal Plan for Middle East is necessary to extend the life of  
17 the Plan, and to remove certain properties from the lists in Appendices A, C, and D.

18 Under Article 13, § 2-6 of the Baltimore City Code, no change may be made in any approved  
19 renewal plan unless the change is approved in the same manner as that required for the approval  
20 of a renewal plan.

21 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That the  
22 following changes in the Urban Renewal Plan for Middle East are approved:

15           **SECTION 2. AND BE IT FURTHER ORDAINED,** That the Urban Renewal Plan for Middle East,  
16 as amended by this Ordinance and identified as “Urban Renewal Plan, Middle East, revised to  
17 include Amendment 15, dated September 19, 2022”, is approved. The Department of Planning  
18 shall file a copy of the amended Urban Renewal Plan with the Department of Legislative  
19 Reference as a permanent public record, available for public inspection and information.

20           **SECTION 3. AND BE IT FURTHER ORDAINED,** That if the amended Urban Renewal Plan  
21 approved by this Ordinance in any way fails to meet the statutory requirements for the content of  
22 a renewal plan or for the procedures for the preparation, adoption, and approval of a renewal  
23 plan, those requirements are waived and the amended Urban Renewal Plan approved by this  
24 Ordinance is exempted from them.


25           **SECTION 4. AND BE IT FURTHER ORDAINED,** That if any provision of this Ordinance or the  
26 application of this Ordinance to any person or circumstance is held invalid for any reason, the  
27 invalidity does not affect any other provision or any other application of this Ordinance, and for  
28 this purpose the provisions of this Ordinance are declared severable.

29           **SECTION 5. AND BE IT FURTHER ORDAINED,** That if a provision of this Ordinance concerns  
30 the same subject as a provision of any zoning, building, electrical, plumbing, health, fire, or  
31 safety law or regulation, the applicable provisions shall be construed to give effect to each.  
32 However, if the provisions are found to be in irreconcilable conflict, the one that establishes the  
33 higher standard for the protection of the public health and safety prevails. If a provision of this  
34 Ordinance is found to be in conflict with an existing provision of any other law or regulation that  
35 establishes a lower standard for the protection of the public health and safety, the provision of  
36 this Ordinance prevails and the other conflicting provision is repealed to the extent of the  
37 conflict.

38           **SECTION 6. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the date it is  
39 enacted.
