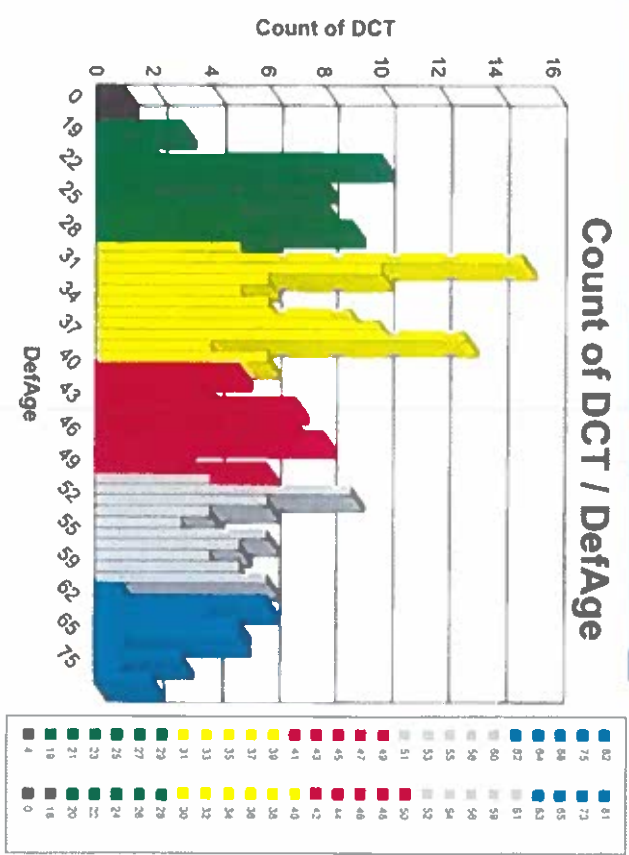

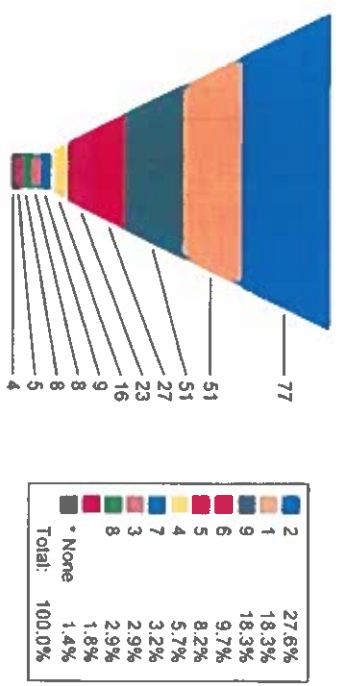

Littering: § 7-702. Littering prohibited. No person may: (1) litter on any public or private property ., \$500 for each offense

Open Container: § 14-2. Prohibited conduct: (a) It is unlawful for any person to e consume any alcoholic beverage (**must name beverage**) in or on any public street. **OR**

It is unlawful to possess in an open container any alcoholic beverage (**must name beverage**), in or on any public street. \$1,000 or imprisonment for not more than 30 days or both fine.

Aggressive Panhandling

§ 47-1. Definitions: (a) Aggressive soliciting: means soliciting which is accompanied by 1 or more of the following: (1) approaching, speaking to, or following a person in such a manner as would cause a reasonable person to fear bodily harm or the commission of a criminal act upon the person or upon property in the person's immediate possession; (2) in the course of soliciting, touching another person without that person's consent; (3) continuously soliciting from a person or following the person after the person has made a negative response; (4) intentionally blocking or interfering with the safe passage of a person or a vehicle by any means, including unreasonably causing a person to take evasive action to avoid physical contact; (5) using obscene or abusive language either during the course of soliciting or following a refusal; or (6) acting with the intent of intimidating another person into giving money or another thing of value.
\$100 or imprisoned for not more than 30 days, or both

Disorderly Drinking

§ 13-1. Prohibited conduct - in general. A person may not: (1) be intoxicated and endanger the safety of another person or property; or (2) be intoxicated or drink any alcoholic beverage in a public place and cause a public disturbance. \$1,000 or imprisonment for not more than 90 days or both fine

Loitering

ART. 19, § 25-2 It shall be unlawful for any person to loiter at a public place or place open to the public and to fail to obey the direction of a uniformed police officer or the direction of a properly identified police officer not in uniform to move on, when not to obey such direction shall endanger the public peace. (c) Scope. (1) No person shall be charged with a violation of this section unless and until the arresting officer has first warned the person of the violation and the person has failed or refused to stop the violation. \$500 or imprisonment for not more than 10 days, or both

Public Urination

§ 5-503. Urinating or defecating in public places — in general. No person may urinate or defecate on or about: (1) any public place, way, or park; or (2) the mall or adjacent parking area of any shopping center. \$1,000 or to imprisonment for not more than 30 days or to both fine

Dirt Bikes

§ 40-6. Driving or riding; leaving un-immobilized. (a) Driving or riding vehicle. No person may drive or ride any dirt bike or any unregistered motorcycle or similar vehicle on any public or private property that is located in Baltimore City or, wherever located, that is owned or regulated by the City. (b) Possessing un-immobilized vehicle. No person may own, control, possess, or have custody of any dirt bike or any unregistered motorcycle or similar vehicle in Baltimore City unless the vehicle is securely locked or otherwise immobilized by a wheel clamp or other object, device, method, or mechanism, whether attached to the vehicle or not, that: (1) prevents the vehicle from being freely moved; and \$1,000 and/or for each offense or to imprisonment for not more than 90 days
