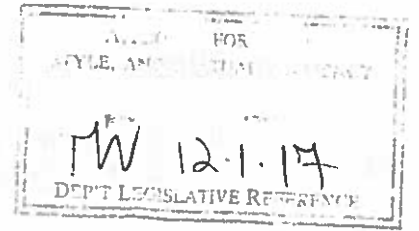


AMENDMENTS TO COUNCIL BILL 17-0144

Amendment No. 1

On page 1, in line 2, after “Services” insert “Permits,”; and, on that same page, in line 3, after “services” insert “,permits,,”; and, in line 17, after “SERVICES” insert “,PERMITS,,”; and, on page 2, in line 1, after “SERVICES” insert “,PERMITS,,”; and, on page 2, in line 22, after “SERVICES” insert “,PERMITS,,”.

Amendment No. 2

ADOPTED

On page 1, in line 20, strike “THE NET PROCEEDS FROM ANY ” and substitute “AN”; and, on that same page, in line 21, strike “ARE TO BE USED EXCLUSIVELY FOR THE BENEFIT OF ” and substitute “IS OPEN TO THE PUBLIC WITHOUT CHARGE AND SPONSORED BY ”; and, on page 2, in line 2, strike “RATE” and substitute “RATES”.

Amendment No. 3

On page 2, in lines 12 and 13, strike “THE BALTIMORE DEVELOPMENT CORPORATION’S” and substitute “THE MAYOR’S OFFICE OF MINORITY & WOMEN-OWNED BUSINESS DEVELOPMENT’S”.

Amendment No. 4

On page 2, in line 16, strike “AND”; and, on that same page, in line 18, after “CLUBS” insert “AND:”

(E) SPORTS ORGANIZATIONS WITH 15 OR MORE BALTIMORE CITY YOUTH AGED 18 YEARS OLD OR YOUNGER AS PARTICIPANTS ”.

Amendment No. 5

On page 2, in line 18, strike “ASSOCIATED” and substitute “ORGANIZED”.

Amendment No. 6

On page 2, in line 20, after “EVIDENCE” insert “TO THE DIRECTOR OF TRANSPORTATION, OR THE DIRECTOR’S DESIGNEE.”.

Amendment No. 7

On page 2, in line 30, strike, “OR”; and, on that same page, in line 31, after “AUTHORITY”, insert “;

(3) FEES CHARGED BY THE DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT FOR TEMPORARY STRUCTURES PURSUANT TO BUILDING CODE § 109.6.1.M {“TEMPORARY STRUCTURES”}; OR

(4) FEES CHARGED BY THE FIRE DEPARTMENT”.

Amendment No. 8

On page 1, in line 4, after “exemptions;” insert “providing for a special effective date;”; and, on page 3, in line 11, strike, “30th”; and substitute “60th”.
