12 ~~For all newly-erected structures and all newly-established uses of land, accessory off-street~~
13 ~~parking facilities must be provided for that structure and use, as required by this title.~~

14 **~~§ 10-206. Spaces to be used exclusively for parking.~~**

15 ~~(a) *In general.*~~

16 ~~(1) All VEHICLE parking spaces required by this title must be used solely for the parking~~
17 ~~of motor vehicles.~~

18 ~~(2) ALL BICYCLE PARKING SPACES REQUIRED BY THIS TITLE MUST BE USED SOLELY FOR~~
19 ~~THE PARKING OF BICYCLES.~~

20 ~~(b) *Specifically prohibited uses.*~~

21 ~~(1) In no event, may required parking spaces be used for the temporary or permanent~~

23 ~~(2) No [motor] vehicle repair work or service of any kind, except emergency repair~~

26 ~~(a) *In Business or Industrial District.*~~

27 ~~(1) Except as specified in paragraph (2) of this subsection, if the application of this title~~
28 ~~results in a requirement of no more than 2 VEHICLE PARKING spaces on a single lot in~~
29 ~~a Business or Industrial District, those off-street parking spaces need not be provided.~~

2 ~~(A) VEHICLE PARKING SPACES.~~

3 Each VEHICLE parking space must be at least 180 square feet, exclusive of access drives
4 or aisles.

5 ~~(B) BICYCLE PARKING SPACES.~~

6 ~~(1) EACH BICYCLE PARKING SPACE MUST BE:~~

7 ~~(I) FOR AN OUTDOOR SPACE, AT LEAST 4 FEET BY 6 FEET; AND~~

8 ~~(II) FOR AN ENCLOSED SPACE, AT LEAST 15 SQUARE FEET OF OPEN FLOOR AREA.~~

9 ~~(2) EACH BICYCLE PARKING SPACE MUST BE EQUIPPED WITH A BICYCLE RACK OR LOCKER~~
10 ~~THAT CAN ACCOMMODATE UP TO 2 BICYCLES PER RACK OR LOCKER.~~

11 ~~§ 10-306. Required access.~~

12 ~~(a) To street or alley.~~

13 Each VEHICLE parking space must be designed with safe and efficient means of vehicular
14 access to:

15 ~~(1) a street; or~~

16 ~~(2) an alley at least 15 feet wide.~~

17 ~~(b) Design of driveways and ramps.~~

18 In establishing VEHICLE parking spaces under this title, driveways or access ramps must
19 be designed and constructed in a way that permits vehicles to enter or leave the parking
20 spaces without having to move any other vehicle onto the public way.

21 ~~§ 10-307. Surfacing.~~

22 ~~(a) In general.~~

23 Except as specified in subsection (b) of this section, VEHICLE parking spaces must be
24 surfaced and maintained with a dustless all-weather material in accordance with the
25 Building Code of Baltimore City.

26 ~~(b) Single and 2-family dwellings.~~

27 For single and 2-family dwellings, a VEHICLE parking space may consist of 2 parallel
28 paved parking strips, each of which is at least 18 inches wide and at least 20 feet long.

29 ~~§ 10-308. Screening and landscaping near Residence or Office-Residence Districts.~~

30 ~~(a) When screening required.~~

Screening is required for any parking facility with 5 or more VEHICLE parking spaces, if the facility:

(1) either adjoins or is within 100 feet of a lot in a Residence or Office-Residence District; and

(2) is visible from the ground level of the Residence or Office-Residence District.

~~EACH BICYCLE PARKING SPACE MUST BE:~~

~~(1) PROVIDED IN A SAFE AND SECURE LOCATION THAT IS ACCESSIBLE TO ALL PROPERTY USERS;~~

~~(2) AT LEAST AS CONVENIENTLY LOCATED AS THE MOST CONVENIENT PARKING SPACE NOT RESERVED FOR PERSONS WITH DISABILITIES; AND~~

~~(3) CLEARLY LABELED AS RESERVED FOR BICYCLE PARKING.~~

~~Subtitle 4. Required Number of Off-Street Spaces~~

~~§ 10-402. Computation of spaces.~~

~~(a) Fractional spaces.~~

~~When the application of this [subtitle] TITLE results in a requirement for a fractional PARKING space:~~

~~(1) any fraction less than 1/2 may be disregarded; and~~

~~(2) any fraction of 1/2 or more counts as 1 parking space.~~

~~(b) Employee-based requirements.~~

~~Where VEHICLE parking spaces are required on a number-of-employee basis, the spaces must be computed on the greatest number of on-duty employees on the premises at any one time.~~

~~(c) Rated-capacity-based requirements.~~

~~Where VEHICLE parking spaces are required on a rated capacity in persons basis, the "rated capacity" is the maximum number of people that, as determined by the Zoning Administrator, may reasonably be accommodated by the use at any one time.~~

~~(B) VEHICLE PARKING SPACE OFFSET.~~

~~(1) THE NUMBER OF VEHICLE PARKING SPACES REQUIRED BY THIS TITLE IS REDUCED BY 1

~~(i) EACH BICYCLE PARKING SPACE PROVIDED AS REQUIRED BY THIS SECTION; AND~~

§ 14-1. DEFINITIONS.

(A) *IN GENERAL.*

IN THIS SUBTITLE, THE FOLLOWING TERMS HAVE THE MEANINGS INDICATED.

(B) *BICYCLE.*

“BICYCLE” HAS THE MEANING STATED IN § 11-104 {“BICYCLE”} OF THE STATE
TRANSPORTATION ARTICLE.

(C) *BICYCLE PARKING SPACE.*

“BICYCLE PARKING SPACE” MEANS A DESIGNATED AREA, WHETHER OPEN OR ENCLOSED,
THAT IS USED FOR THE OFF-STREET PARKING OF A BICYCLE.

(D) *EMPLOYER.*

“EMPLOYER” MEANS ANY PERSON WHO EMPLOYS 10 OR MORE FULL-TIME OR PART-TIME
EMPLOYEES IN THE CITY OF BALTIMORE.

4 (1) AN INDIVIDUAL;

5 (2) A PARTNERSHIP, FIRM, ASSOCIATION, CORPORATION, OR OTHER ENTITY OF ANY
6 KIND; AND

7 (3) A RECEIVER, TRUSTEE, GUARDIAN, PERSONAL REPRESENTATIVE, FIDUCIARY, OR
8 REPRESENTATIVE OF ANY KIND.

10 ~~“PERSON” DOES NOT INCLUDE, UNLESS OTHERWISE EXPRESSLY PROVIDED, A

13 **§ 14-2. RULES AND REGULATIONS.**

14 (A) *DOT TO ADOPT*.

15 THE DIRECTOR OF TRANSPORTATION MAY ADOPT RULES AND REGULATIONS TO
16 IMPLEMENT THIS SUBTITLE.

17 (B) *FILING WITH LEGISLATIVE REFERENCE*.

18 A COPY OF ALL RULES AND REGULATIONS ADOPTED UNDER THIS SUBTITLE MUST BE FILED
19 WITH THE DEPARTMENT OF LEGISLATIVE REFERENCE BEFORE THEY BECOME EFFECTIVE.

20 **§§ 14-3 TO 14-5. {RESERVED}**

21 **§ 14-6. REQUIRED BICYCLE PARKING.**

22 (A) *SCOPE*.

23 BICYCLE PARKING SPACES REQUIRED BY THIS SUBTITLE ARE IN ADDITION TO ANY PARKING
24 SPACES OTHERWISE REQUIRED BY TITLE 10 {“OFF-STREET PARKING REGULATIONS”} OF
25 THE ZONING CODE.

26 (B) *GENERAL REQUIREMENTS*.

27
28 EVERY EMPLOYER MUST PROVIDE ITS EMPLOYEES WITH AT LEAST 1 BICYCLE PARKING
29 SPACE FOR EVERY 10,000 SQUARE FEET OF FLOOR AREA (AS DETERMINED UNDER ZONING
30 CODE § 10-401) IN USE AT THE EMPLOYER’S PLACE OF BUSINESS.

1 (C) *FRACTIONAL SPACES.*

2 WHEN THE APPLICATION OF THIS SECTION RESULTS IN A REQUIREMENT FOR A FRACTIONAL
3 BICYCLE PARKING SPACE:

4 (1) ANY FRACTION LESS THAN 1/2 MAY BE DISREGARDED; AND

5 (2) ANY FRACTION OF 1/2 OR MORE COUNTS AS 1 BICYCLE PARKING SPACE.

6 **§ 14-7. SPECIFICATIONS.**

7 (A) *SIZE AND CAPACITY.*

8 (1) EACH BICYCLE PARKING SPACE MUST BE:

9 (I) FOR AN OUTDOOR SPACE, AT LEAST 4 FEET BY 6 FEET; AND

10 (II) FOR AN ENCLOSED SPACE, AT LEAST 15 SQUARE FEET OF OPEN FLOOR AREA.

11 (2) EACH BICYCLE PARKING SPACE MUST BE EQUIPPED WITH A BICYCLE RACK OR LOCKER
12 THAT CAN ACCOMMODATE UP TO 2 BICYCLES PER RACK OR LOCKER.

13 (B) *ADDITIONAL REQUIREMENTS.*

14 EACH BICYCLE PARKING SPACE MUST BE:

15 (1) PROVIDED IN A SAFE AND SECURE LOCATION THAT IS ACCESSIBLE TO ALL
16 EMPLOYEES;

17 (2) LOCATED ON THE PREMISES OF THE EMPLOYER'S PLACE OF BUSINESS; AND

18 (3) CLEARLY LABELED AS RESERVED FOR BICYCLE PARKING BY EMPLOYEES;.

19 **§§ 14-8 TO 14-10. {RESERVED}**

20 **§ 14-11. PENALTIES.**

21 ANY EMPLOYER WHO VIOLATES A PROVISION OF THIS SUBTITLE OR OF A RULE OR REGULATION
22 ADOPTED UNDER THIS SUBTITLE IS GUILTY OF A MISDEMEANOR AND, ON CONVICTION, IS
23 SUBJECT TO A FINE OF NOT MORE THAN \$500.

24 **SECTION 2. AND BE IT FURTHER ORDAINED,** That the catchlines contained in this Ordinance
25 are not law and may not be considered to have been enacted as a part of this or any prior
26 Ordinance.

27 **SECTION 3. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the 185th
28 day after the date it is enacted.
