A RESOLUTION ENTITLED

1 A COUNCIL RESOLUTION concerning

2 **Approval for the Exchange of a Class B-D-7 License to a**  
3 **Class A-7 License – 1300-1302 Laurens Street**

4 FOR the purpose of providing the required approval under Md. Code Ann., Alc. Bev. § 12-  
5 902.1(d)(1) to allow the license holder holding a valid Class B-D-7 Beer, Wine, and Liquor  
6 License issued for use at 1300-1302 Laurens Street, Baltimore, Maryland 21217 to apply to  
7 the Board of Liquor License Commissioners for Baltimore City to exchange their Class B-D-  
8 7 Beer, Wine, and Liquor License for a Class A-7 Beer, Wine, and Liquor License.

9 **Recitals**

10 Under Md. Code Ann., Alc. Bev. § 12-902.1(d)(1), a City Council resolution is required to  
11 allow a current holder of a valid Class B-D-7 Beer, Wine, and Liquor License issued on or before  
12 July 1, 2018, to apply to the Board of Liquor License Commissioners for Baltimore City (the  
13 “Board”) to exchange their Class B-D-7 Beer, Wine, and Liquor License for a Class A-7 Beer,  
14 Wine, and Liquor License.

15 The Class A-7 License authorizes the license holder to sell beer, wine, and liquor at retail at  
16 the place described in the license for off-premise consumption. The holder of a Class A-7  
17 License may sell beer, wine, and liquor on Monday through Sunday from 10:00 a.m. to midnight.

18 57 Liquors, Inc., wishes to apply to the Board to exchange the Class B-D-7 License issued for  
19 use at 1300-1302 Laurens Street for a Class A-7 License. Accordingly, representatives of 57  
20 Liquors, Inc., have applied to the Baltimore City Council for approval of the exchange.

21 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE**, That the City  
22 Council authorizes, by and through this Resolution, that the current holder of the Class B-D-7  
23 Beer, Wine, and Liquor License issued for use at 1300-1302 Laurens Street, Baltimore,  
24 Maryland, 21217 may apply to exchange its Class B-D-7 License for a Class A-7 Beer, Wine,  
25 and Liquor License and may be afforded all the privileges and responsibilities of that license  
26 class and type under the Alcoholic Beverages Article for the State of Maryland.

27 **AND BE IT FURTHER RESOLVED**, That a copy of this Resolution be sent to the Executive  
28 Secretary of the Board of Liquor License Commissioners for Baltimore City.
