21	obligations to finance water facilities within the geographical limits of the City's
22	water system. The maximum aggregate principal amount of revenue obligations
23	authorized to be issued under Ordinance 02-331, as last amended by Ordinance
24	11-429. is \$1.017.000.000.

1 2 3 4	Certain recent events have occurred that affect the aggregate principal amount of revenue obligations that may be required to finance water facilities, including (without limitation) an increase in the number of water facilities that the City may desire to finance with the proceeds of the sale of revenue obligations.
5 6 7	Accordingly, the City desires to increase to \$2,152,000,000 the aggregate principal amount of the revenue obligations that may be issued under that Ordinance.
8 9 10	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE , That Section 2(a) of Ordinance 02-331, as last amended by Ordinance 11-429, is amended and restated to read as follows:
1	SECTION 2. AND BE IT FURTHER ORDAINED, That:
12 13 14 15	(a) Revenue obligations may be issued from time to time in an aggregate principal amount not to exceed [\$1,017,000,000] \$2,152,000,000 for the general public purposes of financing or refinancing the cost of the financed facilities and repaying the City for amounts expended on financed facilities in anticipation of the issuance of the revenue obligations.
17 18	SECTION 2. AND BE IT FURTHER ORDAINED , That Ordinance 02-331, as last amended by Ordinance 11-429 and this Ordinance, continues in full force and effect.
