16	The revenue appropriated by this Ordinance represents funds from the Fiscal 2006 Fund
17	Balance in excess of the revenue relied on by the Board of Estimates in determining the tax levy
18	required to balance the budget for Fiscal Year 2007.
19	This additional revenue could not have been reasonably anticipated when the Ordinance of
20	Estimates for Fiscal Year 2007 was formulated.
21	This appropriation is made necessary by a material change in circumstances since the
22	Ordinance of Estimates for Fiscal Year 2007 was formulated or is for a new program that could
23	not have been reasonably anticipated when that Ordinance of Estimates was formulated.
24	On August 9, 2006, the Board of Estimates recommended this appropriation to the City

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That
\$2,000,000 shall be made available to the Department of Housing and Community Development
 Program 177 (Administrative Direction and Control) as a Supplementary General Fund
Operating Appropriation for Fiscal Year 2007, to provide funding to replace Urban Development
Action Grant funds not forthcoming to the City due to renovations being performed at the Hyatt
Hotel located in the Inner Harbor. The source of revenue for this appropriation is from the Fiscal
2006 Fund Balance in excess of the amount from this source that was relied on by the Board of
Estimates in determining the tax levy required to balance the budget for Fiscal Year 2007.

SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it is enacted.
