A BILL ENTITLED

1 AN ORDINANCE concerning

2 **Supplementary General Fund Capital Appropriation –**  
3 **Mayoralty-Related – \$200,000**

4 FOR the purpose of providing a Supplementary General Fund Capital Appropriation in the  
5 amount of \$200,000 to the Mayoralty-Related (Account #9904-129-301), to provide funding  
6 to commission a memorial to the late Mayor Clarence H. “Du” Burns; and providing for a  
7 special effective date.

13 **Recitals**

14 The revenue appropriated by this Ordinance represents funds from the FY 2007 Income Tax  
15 in excess of the revenue relied on by the Board of Estimates in determining the tax levy required  
16 to balance the budget for Fiscal Year 2007.

17 This additional revenue could not have been reasonably anticipated when the Ordinance of  
18 Estimates for Fiscal Year 2007 was formulated.

19 This appropriation is made necessary by a material change in circumstances since the  
20 Ordinance of Estimates for Fiscal Year 2007 was formulated or is for a new program that could  
21 not have been reasonably anticipated when that Ordinance of Estimates was formulated.

22 On May 9, 2007, the Board of Estimates recommended this appropriation to the City  
23 Council.

24 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That  
25 \$200,000 shall be made available to the Mayoralty-Related (Account #9904-129-301) as a  
26 Supplementary General Fund Capital Appropriation for Fiscal Year 2007, to provide funding to  
27 commission a memorial of the late Mayor Clarence H. “Du” Burns. The source of revenue for

1 this appropriation is funds from the Fiscal 2007 Income Tax in excess of the amount from this  
2 source that was relied on by the Board of Estimates in determining the tax levy required to  
3 balance the budget for Fiscal Year 2007.

4 **SECTION 2. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the date it  
5 is enacted.
