16	(A) AUTHORITY TO EMPLOY.
17	THE PRESIDENT OF THE CITY COUNCIL MAY EMPLOY THE SERVICES OF AN INDEPENDENT
18	DIRECTOR OF BUDGET AND FINANCE. THE SELECTION AND EMPLOYMENT OF THE
19	DIRECTOR OF BUDGET AND FINANCE SHALL BE CONSISTENT WITH THIS SECTION, AS
20	SUPPLEMENTED BY THE RULES OF THE CITY COUNCIL.

2	THE DIRECTOR OF BUDGET AND FINANCE:
3 4 5	(1) SHALL POSSESS A MASTER'S DEGREE FROM AN ACCREDITED COLLEGE OR UNIVERSITY IN ACCOUNTING, BUSINESS ADMINISTRATION, FINANCE, OR PUBLIC ADMINISTRATION;

20 21	The Director of Budget and Finance serves at the pleasure of the President of the City Council .
22	(D) DUTIES.
23 24	AS THE PRESIDENT OF THE CITY COUNCIL DIRECTS, THE DIRECTOR OF BUDGET AND FINANCE SHALL:
25 26	(1) PROVIDE INDEPENDENT BUDGET AND FINANCE ADVICE TO THE CITY COUNCIL, ITS COMMITTEES, AND SUBCOMMITTEES;
27 28	(2) FURNISH FISCAL IMPACT STATEMENTS TO THE CITY COUNCIL, ITS COMMITTEES, AND SUBCOMMITTEES, AS REQUESTED; AND
29 30	(3) ASSIST THE CITY COUNCIL IN ANALYZING FINANCIAL MATTERS BEFORE THE CITY COUNCIL, ITS COMMITTEES, AND SUBCOMMITTEES.
31	(E) COMPENSATION; EXPENSES.
32 33 34	(1) THE DIRECTOR OF BUDGET AND FINANCE'S COMPENSATION SHALL BE AT LEAST EQUAL TO THAT OF A FULL-TIME DEPUTY FINANCE DIRECTOR IN THE DEPARTMENT OF FINANCE OR AN OPERATIONS DIRECTOR II, WHICHEVER IS GREATER.

1	(2) THE BOARD OF ESTIMATES SHALL ANNUALLY INCLUDE IN THE ORDINANCE OF
2	ESTIMATES SUBMITTED TO THE CITY COUNCIL AN AMOUNT SUFFICIENT TO FUND THE
3	DIRECTOR'S COMPENSATION AND NECESSARY EXPENSES.
4	(3) THE AMOUNT APPROPRIATED FOR THE DIRECTOR'S COMPENSATION AND EXPENSES
5	SHALL BE IN ADDITION TO AND MAY NOT SUPPLANT, BE DEDUCTED FROM, OR SERVE AS
6	A BASIS FOR REDUCING ANY PART OF THE OPERATING BUDGET OF THE CITY COUNCIL.
7	SECTION 2. AND BE IT FURTHER RESOLVED, That this proposed amendment to the City
8	Charter be submitted to the legal and qualified voters of Baltimore City, for adoption or rejection,
9	in accordance with Article XI-A, § 5 of the Maryland Constitution, in the form specified by the
0	City Solicitor.
