BACKGROUND/EXPLANATION:

The Recommended Budget totals \$3.951 billion for operating and \$1.070 billion for capital projects. The recommended General Fund budget is \$2.82 billion, an increase of 8.46% from the Fiscal 2026 Adopted Budget.

On June 17, 2026, the Baltimore City Council's Budget and Appropriations Committee voted to advance the Ordinance of Estimates out of committee with a favorable report, including amendments. The approved amendments are attached.

33 notes, revenue bonds and notes, leases, conditional purchase agreements and other
34 obligations of the City (or any entity controlled by the City within the meaning of
35 Treas. Reg. Section 1.150-1).
- 36 (c) The maximum anticipated debt expected to be incurred by the City to reimburse the
37 cost of each capital project or program in this Ordinance of Estimates is the applicable
38 appropriation listed in this Ordinance of Estimates from the proceeds of one or more
39 obligations, as such appropriations may be increased or decreased.
